SUMMARY:

House Bill 5118 would amend Section 308 of the Mental Health Code (MCL 330.1308) to require state payments to local Community Mental Health Services Programs (CMHSPs) to be calculated and made based on relevant factors in the county, including demographics, unemployment rates, and poverty levels.

This bill would also require the Department of Health and Human Services (DHHS) to work with actuaries to update funding methodologies to be based on a common statewide rate with adjustments for morbidity.

FISCAL IMPACT:

The overall level of state funding for local CMHSPs are ultimately based on the state appropriations process, meaning this bill would have no fiscal impact on the state. The FY 2016-17 state appropriation for non-Medicaid community mental health services is \$120.1 million. Without an increase in state appropriations, however, this bill would result in CMHSPs experiencing either an allocation increase or an allocation decrease. Without a specific statutory formula, HFA cannot project who those "winners" or "losers" would be. For reference, a table showing FY 2014-15 CMHSP allocations, percentage of statewide population, unemployment rates, and poverty levels by CMHSP is included at the end of this legislative analysis.

Currently, state payments to CMHSPs for non-Medicaid mental health services are based almost entirely on historic costs and each CMHSP's request for state funding. Chapter 2 of the Mental Health Code requires DHHS to review each CMHSP's annual request for state funding and to allocate available state appropriations accordingly, while considering a reasonable degree of statewide standardization and a reasonable expectation that CMHSPs will receive continuing state financial support.
