

HOUSE BILL No. 4060

January 27, 2015, Introduced by Reps. Hughes, Rendon, Graves, Glenn, Heise, Hooker, Rutledge, Outman, Bumstead, Lyons, Price, Crawford, Yonker, Runestad, Kelly, Chatfield, Barrett, Callton, Muxlow and Jenkins and referred to the Committee on Military and Veterans Affairs.

A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
(MCL 388.1601 to 388.1896) by adding section 275b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 275B. (1) EACH PUBLIC UNIVERSITY RECEIVING FUNDS UNDER
2 SECTION 236 SHALL ENSURE THAT THE PUBLIC UNIVERSITY DOES ALL OF THE
3 FOLLOWING IN ITS ADMISSION APPLICATION PROCESS IF IT KNOWS THAT AN
4 APPLICANT FOR ADMISSION IS CURRENTLY SERVING, OR HAS EVER SERVED,
5 AS A MEMBER OF THE MILITARY, THE NATIONAL GUARD, OR THE MILITARY
6 RESERVES:

7 (A) INFORM THE APPLICANT THAT HE OR SHE MAY RECEIVE ACADEMIC
8 CREDIT FOR COLLEGE-LEVEL TRAINING AND EDUCATION HE OR SHE RECEIVED
9 WHILE SERVING IN THE MILITARY.

10 (B) INFORM THE APPLICANT THAT HE OR SHE MAY SUBMIT A
11 TRANSCRIPT OF HIS OR HER COLLEGE-LEVEL MILITARY TRAINING AND

1 EDUCATION TO THE PUBLIC UNIVERSITY.

2 (C) IF THE APPLICANT SUBMITS A TRANSCRIPT DESCRIBED IN
3 SUBDIVISION (B), EVALUATE THAT TRANSCRIPT AND NOTIFY THE APPLICANT
4 OF WHAT TRANSFER CREDITS ARE AVAILABLE TO THE APPLICANT FROM THE
5 PUBLIC UNIVERSITY FOR HIS OR HER COLLEGE-LEVEL MILITARY TRAINING
6 AND EDUCATION.

7 (2) AS USED IN THIS SECTION, "TRANSCRIPT" INCLUDES A JOINT
8 SERVICES TRANSCRIPT PREPARED FOR THE APPLICANT UNDER THE AMERICAN
9 COUNCIL ON EDUCATION REGISTRY OF CREDIT RECOMMENDATIONS.

10 Enacting section 1. This amendatory act takes effect 90 days
11 after the date it is enacted into law.
