

# HOUSE BILL No. 4501

April 22, 2015, Introduced by Rep. Heise and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending sections 12m and 16e of chapter XVII (MCL 777.12m and  
777.16e), section 12m as amended by 2005 PA 54 and section 16e as  
added by 1998 PA 317.

### 1 CHAPTER XVII
