May 3, 2016, Introduced by Reps. Hooker, Cole, Vaupel, McCready, LaVoy, Victory, Price, Crawford, Howell, Iden, Canfield, Tedder, Runestad and McBroom and referred to the Committee on Judiciary.

A bill to amend 1939 PA 288, entitled "Probate code of 1939," by amending section 55 of chapter X (MCL 710.55), as added by 1994 PA 222.

CHAPTER X

Sec. 55. (1) Only a person specified in sections 23a(1), 23b(1), and 23c of this chapter may place a child for adoption. ~~Only a~~ **A** prospective adoptive parent may **ADVERTISE FOR**, solicit, **OR RECRUIT** biological parents or guardians of potential adoptees for the purposes of **A COURT-SUPERVISED** adoption. ~~Only a~~ **A** biological parent or guardian, ~~or~~ the court, department, or child placing agency with authority to place a child may **ADVERTISE FOR**, solicit, **OR RECRUIT** potential adoptive parents ~~for~~ **ONLY TO FULFILL THE**

 9 years or a fine of not more than \$2,000.00, or both, for each
 10 subsequent violation. The court may enjoin from further violations
 11 any person who violates this section.

 13 **RECRUIT**" means ~~contact~~ **TO COMMUNICATE** in person, ~~by telephone or~~

 15 ~~directed to a specific recipient. Solicit does not include public~~
 16 ~~communication that is not directed to specific individuals.~~ **IN**
 17 **WRITING, OR VIA ANY MEDIUM, PUBLIC OR PRIVATE, FOR THE PURPOSE OF**
 18 **LOCATING A PREVIOUSLY UNKNOWN PERSON OR ENTITY WITH WHOM TO**
 19 **TEMPORARILY OR PERMANENTLY PLACE A CHILD.**

20 Enacting section 1. This amendatory act takes effect 90 days
