## HOUSE SUBSTITUTE FOR SENATE BILL NO. 218

A bill to amend 2004 PA 46, entitled "Public safety officers benefit act," by amending the title and section 2 (MCL 28.632) and by adding section 4a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 TITLE
- 2 An act to provide compensation AND OTHER BENEFITS to
- 3 dependents of public safety officers who are killed or who are
- 4 permanently and totally disabled in the line of duty; to create the
- 5 public safety officers benefit fund; to prescribe the duties and
- 6 responsibilities of certain state officers; and to make an
- 7 appropriation.
- 8 Sec. 2. As used in this act:

- 1 (a) "Commission" means the commission on law enforcement
- 2 standards created under the commission on law enforcement standards
- 3 act, 1965 PA 203, MCL 28.601 to 28.616.
- 4 (b) "Dependent" means any individual who was substantially
- 5 reliant for support upon the income of the deceased public safety
- 6 officer.
- 7 (c) "Direct and proximate" means that the antecedent event is
- 8 a substantial factor in the result.
- 9 (d) "Firefighter" means a regularly employed member of a fire
- 10 department of a city, county, township, village, state university,
- 11 or community college OR ANY AUTHORITY, DISTRICT, BOARD, OR OTHER
- 12 ENTITY CREATED IN WHOLE OR IN PART BY 1 OR MORE CITIES, COUNTIES,
- 13 VILLAGES, OR TOWNSHIPS, or a member of the department of natural
- 14 resources who is employed to fight fires. Firefighter includes a
- 15 volunteer member of a fire department.
- 16 (e) "Law enforcement officer" means an individual involved in
- 17 crime and juvenile delinquency control or reduction or enforcement
- 18 of the criminal law. Law enforcement officer includes police,
- 19 corrections, probation, parole, bailiffs, or other similar court
- 20 officers.
- 21 (f) "Line of duty" means either of the following:
- 22 (i) Any action which an officer whose primary function is
- 23 crime control or reduction, enforcement of the criminal law, or
- 24 suppression of fires is obligated or authorized by rule,
- 25 regulations, condition of employment or service, or law to perform,
- 26 including those social, ceremonial, or athletic functions to which
- 27 the officer is assigned, or for which the officer is compensated,

- 1 by the public agency he or she serves. For other officers, line of
- 2 duty means any action the officer is so obligated or authorized to
- 3 perform in the course or controlling or reducing crime, enforcing
- 4 the criminal law, or suppressing fires.
- 5 (ii) Any action which an officially recognized or designated
- 6 public employee member of a rescue squad or ambulance crew is
- 7 obligated or authorized by rule, regulation, condition of
- 8 employment or service, or law to perform.
- 9 (G) "MEDICAL BENEFIT PLAN" MEANS A PLAN TO PROVIDE FOR THE
- 10 PAYMENT OF MEDICAL, OPTICAL, OR DENTAL BENEFITS, INCLUDING, BUT NOT
- 11 LIMITED TO, HOSPITAL AND PHYSICIAN SERVICES, PRESCRIPTION DRUGS,
- 12 AND RELATED BENEFITS.
- (H) (g) "Member of a rescue squad or ambulance crew" means AN
- 14 EMERGENCY MEDICAL TECHNICIAN, A MEDICAL FIRST RESPONDER, OR A
- 15 PARAMEDIC, AS THOSE TERMS ARE DEFINED IN SECTIONS 20904, 20906, AND
- 16 20908 OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.20904,
- 17 333.20906, AND 333.20908, OR an officially recognized or designated
- 18 employee or volunteer member of a rescue squad or ambulance crew.
- 19 (I) (h) "Permanent and total disability" means medically
- 20 determinable consequences of a catastrophic, line-of-duty injury
- 21 that permanently prevent a former public safety officer from
- 22 performing any gainful work.
- 23 (J) (i) "Public safety officer" OR "OFFICER" means any
- 24 individual serving a public agency OR ANY AUTHORITY, DISTRICT,
- 25 BOARD, OR OTHER ENTITY CREATED IN WHOLE OR IN PART BY 1 OR MORE
- 26 CITIES, COUNTIES, VILLAGES, OR TOWNSHIPS, in an official capacity,
- 27 with or without compensation, as a law enforcement officer,

- 1 firefighter, rescue squad member, or ambulance crew member.OR
- 2 MEMBER OF A RESCUE SQUAD OR AMBULANCE CREW.
- 3 (K) (i) "Surviving spouse" means the husband or wife of the
- 4 deceased officer at the time of the officer's death, and includes a
- 5 spouse living apart from the officer at the time of the officer's
- 6 death for any reason.
- 7 SEC. 4A. (1) IF A PUBLIC SAFETY OFFICER DIES AS A DIRECT AND
- 8 PROXIMATE RESULT OF A PERSONAL INJURY SUSTAINED IN THE LINE OF DUTY
- 9 ON OR AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED
- 10 THIS SECTION, THIS STATE, UPON NOTICE TO THE OFFICE OF RETIREMENT
- 11 SERVICES FROM THE PUBLIC AGENCY OR ENTITY THE OFFICER SERVED, AND
- 12 SUBJECT TO APPROPRIATION, SHALL PROVIDE TO THE DECEDENT'S SURVIVING
- 13 SPOUSE AND DEPENDENT CHILDREN A COMPARABLE MEDICAL BENEFIT PLAN ON
- 14 COMPARABLE TERMS TO THE MEDICAL BENEFIT PLAN OFFERED TO MICHIGAN
- 15 STATE POLICE TROOPER RETIREES, INCLUDING ANY CHANGE TO THE MEDICAL
- 16 BENEFIT PLAN AFTER THE PUBLIC SAFETY OFFICER'S DEATH. COVERAGE FOR
- 17 A SURVIVING SPOUSE OR DEPENDENT CHILD UNDER THIS SECTION IS NOT
- 18 REQUIRED TO BE PROVIDED FOR MORE THAN 60 MONTHS AFTER THE PUBLIC
- 19 SAFETY OFFICER'S DEATH. COVERAGE UNDER THIS SECTION IS NOT REQUIRED
- 20 TO BE PROVIDED DURING ANY PERIOD DURING WHICH THE SURVIVING SPOUSE
- 21 OR DEPENDENT CHILD, RESPECTIVELY, HAS QUALIFIED FOR AND IS COVERED
- 22 BY A MEDICAL BENEFIT PLAN FROM ANOTHER SOURCE. COVERAGE PROVIDED
- 23 UNDER THIS SECTION ENDS FOR A SURVIVING SPOUSE UPON MEDICARE
- 24 ELIGIBILITY. COVERAGE FOR A DEPENDENT CHILD IS NOT REQUIRED TO BE
- 25 PROVIDED UNDER THIS SECTION AFTER THE LIMITING AGE FOR A DEPENDENT
- 26 CHILD OR ANOTHER TERMINATING EVENT THAT IS PROVIDED IN THE MEDICAL
- 27 BENEFIT PLAN FOR MICHIGAN STATE POLICE TROOPER RETIREES. HOWEVER,

- 1 IF 42 USC 300GG-14 REQUIRES THAT DEPENDENT CHILD ELIGIBILITY BE
- 2 APPLIED MORE BROADLY, THIS STATE SHALL MAKE THE COVERAGE AVAILABLE
- 3 IN COMPLIANCE WITH THAT LAW.
- 4 (2) THIS SECTION DOES NOT REQUIRE THIS STATE TO PROVIDE
- 5 MEDICAL BENEFITS TO A SURVIVING SPOUSE OR DEPENDENT CHILD WHO, AS A
- 6 RESULT OF THE PUBLIC SAFETY OFFICER'S DEATH AND INDEPENDENT OF THIS
- 7 SECTION, WOULD RECEIVE BENEFITS UNDER A MEDICAL BENEFIT PLAN
- 8 THROUGH A RETIREMENT SYSTEM ADMINISTERED BY THIS STATE.
- 9 (3) IN A MANNER DETERMINED BY THE OFFICE OF RETIREMENT
- 10 SERVICES, THE OFFICE OF RETIREMENT SERVICES SHALL ADMINISTER
- 11 BENEFITS PROVIDED UNDER THIS SECTION AS PART OF THE MICHIGAN STATE
- 12 POLICE TROOPER RETIREE MEDICAL BENEFIT PLAN AND MAY COORDINATE THE
- 13 FUNDING OR PREFUNDING OF THOSE BENEFITS. THE OFFICE OF RETIREMENT
- 14 SERVICES SHALL DETERMINE, AT ITS SOLE DISCRETION, IF A MEDICAL
- 15 BENEFIT PLAN IS COMPARABLE AND OFFERED ON COMPARABLE TERMS TO THE
- 16 MEDICAL BENEFIT PLAN OFFERED TO MICHIGAN STATE POLICE TROOPER
- 17 RETIRES FOR PURPOSES OF DETERMINING THE MEDICAL BENEFIT PLAN THAT
- 18 WILL BE OFFERED UNDER THIS SECTION.
- 19 (4) FOR PURPOSES OF THIS SECTION, "DEPENDENT CHILD" MEANS ANY
- 20 OF THE FOLLOWING DEPENDENTS WITH RESPECT TO THE DECEASED PUBLIC
- 21 SAFETY OFFICER:
- 22 (A) HIS OR HER UNMARRIED NATURAL OR ADOPTED CHILD.
- 23 (B) A CHILD LAWFULLY PLACED FOR ADOPTION WITH THE PUBLIC
- 24 SAFETY OFFICER.
- 25 (C) HIS OR HER STEPCHILD.
- 26 (D) A CHILD UNDER THE AGE OF 18 IF FULL LEGAL GUARDIANSHIP WAS
- 27 AWARDED TO THE PUBLIC SAFETY OFFICER.

- (5) IF A DEPENDENT CHILD OF A DECEASED PUBLIC SAFETY OFFICER 1
- 2 IS RECEIVING COVERAGE UNDER THIS SECTION, A CHILD OF THE DEPENDENT
- CHILD IS NOT ALSO A DEPENDENT CHILD FOR PURPOSES OF THIS SECTION. 3
- Enacting section 1. This amendatory act takes effect 90 days
- after the date it is enacted into law. 5
