HOUSE SUBSTITUTE FOR SENATE BILL NO. 245

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 40118 (MCL 324.40118), as amended by 2012 PA 520.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 40118. (1) A person AN INDIVIDUAL who violates this part,
- 2 an order or interim order issued under this part, or a condition of
- 3 a permit issued under this part, except for a violation specified
- 4 in subsections (2) to $\frac{(12)}{(17)}$, is guilty of a misdemeanor
- 5 punishable by imprisonment for not more than 90 days, or a fine of
- 6 not less than \$50.00 or more than \$500.00, or both, and the costs
- 7 of prosecution. In addition, a permit issued by the department
- 8 under this part shall be revoked pursuant to the administrative

- 1 procedures act of 1969, 1969 PA 306, MCL 24.201 to 24.328.
- 2 (2) A person AN INDIVIDUAL who violates a provision of this
- 3 part or an order or interim order issued under this part regarding
- 4 the possession or taking of any game, except deer, bear, wild
- 5 turkey, wolf, WATERFOWL, moose, or elk, is guilty of a misdemeanor
- 6 punishable by imprisonment for not more than 90 days, or a fine of
- 7 not less than \$100.00 or more than \$1,000.00, or both, and the
- 8 costs of prosecution.
- 9 (3) Except as otherwise provided in this subsection, a person
- 10 AN INDIVIDUAL who violates a provision of this part or an order or
- 11 interim order issued under this part regarding the possession or
- 12 taking of deer, bear, wild turkey, or wolf is guilty of a
- 13 misdemeanor and shall be punished by imprisonment for not less than
- 14 5 days or more than 90 days, and a fine of not less than \$200.00 or
- 15 more than \$1,000.00, and the costs of prosecution. A person AN
- 16 INDIVIDUAL shall not be punished under this subsection for lawfully
- 17 removing, capturing, or destroying a wolf under 2008 PA 290, MCL
- 18 324.95151 to 324.95155, or 2008 PA 318, MCL 324.95161 to 324.95167.
- 19 (4) A person AN INDIVIDUAL who violates a provision of this
- 20 part or an order or interim order issued under this part regarding
- 21 the possession or taking of elk is guilty of a misdemeanor
- 22 punishable by imprisonment for not less than 30 days or more than
- 23 180 days, or a fine of not less than \$500.00 or more than
- 24 \$2,000.00, or both, and the costs of prosecution.
- 25 (5) A person AN INDIVIDUAL who violates a provision of this
- 26 part or an order or interim order issued under this part regarding
- 27 the possession or taking of moose is guilty of a misdemeanor and

- 1 shall be punished by imprisonment for not less than 90 days or more
- 2 than 1 year and a fine of not less than \$1,000.00 or more than
- 3 \$5,000.00, and the costs of prosecution.
- 4 (6) AN INDIVIDUAL WHO VIOLATES A PROVISION OF THIS PART OR AN
- 5 ORDER OR INTERIM ORDER ISSUED UNDER THIS PART REGARDING THE
- 6 POSSESSION OR TAKING OF WATERFOWL IS GUILTY OF A MISDEMEANOR
- 7 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS OR A FINE OF
- 8 NOT LESS THAN \$250.00 OR MORE THAN \$500.00, OR BOTH, AND THE COSTS
- 9 OF PROSECUTION. AN INDIVIDUAL WHO VIOLATES A PROVISION OF THIS PART
- 10 OR AN ORDER OR INTERIM ORDER ISSUED UNDER THIS PART REGARDING THE
- 11 POSSESSION OR TAKING OF WATERFOWL A SECOND OR SUBSEQUENT TIME IS
- 12 GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE
- 13 THAN 90 DAYS OR A FINE OF \$500.00, OR BOTH, AND THE COSTS OF
- 14 PROSECUTION.
- 15 (7) (6) A person AN INDIVIDUAL sentenced pursuant to UNDER
- 16 subsection (3), $\frac{(4)}{(5)}$, $\frac{(5)}{(10)}$, or $\frac{(11)}{(14)}$, OR (15) shall not
- 17 secure or possess a license of any kind to hunt during the
- 18 remainder of the year in which convicted and the next 3 succeeding
- 19 calendar years. A person AN INDIVIDUAL sentenced pursuant to UNDER
- 20 subsection $\frac{7}{11}$ shall not secure or possess a license to hunt
- 21 during the remainder of the year in which convicted and the next
- 22 succeeding calendar year, OR LONGER IN THE DISCRETION OF THE COURT.
- 23 (8) IN ADDITION TO THE PENALTIES PROVIDED FOR VIOLATING THIS
- 24 PART OR AN ORDER ISSUED UNDER THIS PART, AN INDIVIDUAL CONVICTED OF
- 25 THE ILLEGAL KILLING, POSSESSING, PURCHASING, OR SELLING OF A BEAR
- 26 OR AN ANTLERED WHITE-TAILED DEER IS SUBJECT TO THE FOLLOWING
- 27 PENALTIES:

- 1 (A) FOR A FIRST OFFENSE, THE INDIVIDUAL SHALL NOT SECURE OR
- 2 POSSESS A LICENSE OF ANY KIND TO HUNT FOR AN ADDITIONAL 2 CALENDAR
- 3 YEARS AFTER THE PENALTIES IMPOSED UNDER SUBSECTION (7).
- 4 (B) FOR A SECOND OR SUBSEQUENT OFFENSE, THE INDIVIDUAL SHALL
- 5 NOT SECURE OR POSSESS A LICENSE OF ANY KIND TO HUNT FOR AN
- 6 ADDITIONAL 7 CALENDAR YEARS AFTER THE PENALTIES IMPOSED UNDER
- 7 SUBSECTION (7).
- 8 (9) IN ADDITION TO THE PENALTIES PROVIDED FOR VIOLATING THIS
- 9 PART OR AN ORDER ISSUED UNDER THIS PART, AN INDIVIDUAL CONVICTED OF
- 10 THE ILLEGAL KILLING, POSSESSING, PURCHASING, OR SELLING OF A WILD
- 11 TURKEY SHALL NOT SECURE OR POSSESS A LICENSE OF ANY KIND TO HUNT
- 12 FOR AN ADDITIONAL 2 CALENDAR YEARS AFTER THE PENALTIES IMPOSED
- 13 UNDER SUBSECTION (7).
- 14 (10) AN INDIVIDUAL SENTENCED UNDER SUBSECTION (4) OR (5) IS
- 15 SUBJECT TO THE FOLLOWING PENALTIES:
- 16 (A) FOR A FIRST OFFENSE, THE INDIVIDUAL SHALL NOT SECURE OR
- 17 POSSESS A LICENSE OF ANY KIND TO HUNT FOR THE REMAINDER OF THE YEAR
- 18 IN WHICH CONVICTED AND THE NEXT 15 SUCCEEDING CALENDAR YEARS.
- 19 (B) FOR A SECOND OFFENSE, THE INDIVIDUAL SHALL NOT SECURE OR
- 20 POSSESS A LICENSE OF ANY KIND TO HUNT FOR THE REMAINDER OF THAT
- 21 INDIVIDUAL'S LIFE.
- 22 (11) (7) A person AN INDIVIDUAL who violates section 40113(1)
- 23 is guilty of a misdemeanor punishable by imprisonment for not less
- 24 than 5 days or more than 90 days, or a fine of not less than
- 25 \$100.00 or more than \$500.00, or both, and the costs of
- 26 prosecution.
- 27 (12) (8) A person AN INDIVIDUAL who violates section 40113(2)

- 1 is guilty of a misdemeanor punishable by imprisonment for not more
- 2 than 90 days, or a fine of not less than \$50.00 or more than
- 3 \$500.00, or both, and the costs of prosecution.
- 4 (13) (9) A person AN INDIVIDUAL who violates section 40113(3)
- 5 is guilty of a misdemeanor and shall be punished by imprisonment
- 6 for not less than 5 days or more than 90 days and a fine of not
- 7 less than \$100.00 or more than \$500.00, and the costs of
- 8 prosecution.
- 9 (14) (10) A person AN INDIVIDUAL who violates a provision of
- 10 this part or an order or interim order issued under this part
- 11 regarding the taking or possession of an animal that has been
- 12 designated by the department to be a protected animal, other than
- 13 an animal that appears on a list prepared pursuant to section
- 14 36505, is guilty of a misdemeanor punishable by imprisonment for
- 15 not more than 90 days or a fine of not less than \$100.00 or more
- 16 than \$1,000.00, or both, and the costs of prosecution.
- 17 (15) (11) A person—AN INDIVIDUAL who buys or sells game or a
- 18 protected animal in violation of this part or an order or interim
- 19 order issued under this part is guilty of a misdemeanor punishable
- 20 by imprisonment for not more than 90 days or a fine of not more
- 21 than \$1,000.00, or both, for the first offense, and is guilty of a
- 22 felony for each subsequent offense.
- 23 (16) AN INDIVIDUAL WHO WILLFULLY VIOLATES A PROVISION OF THIS
- 24 PART OR AN ORDER OR INTERIM ORDER ISSUED UNDER THIS PART BY USING
- 25 AN ILLEGALLY CONSTRUCTED SNARE OR CABLE RESTRAINT IS GUILTY OF A
- 26 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS,
- 27 OR A FINE OF \$1,000.00 FOR THE FIRST ILLEGALLY CONSTRUCTED SNARE OR

- 1 CABLE RESTRAINT AND \$250.00 FOR EACH SUBSEQUENT ILLEGALLY
- 2 CONSTRUCTED SNARE OR CABLE RESTRAINT, OR BOTH, AND THE COSTS OF
- 3 PROSECUTION.
- 4 (17) (12) If a person AN INDIVIDUAL is convicted of a
- 5 violation of this part or an order or interim order issued under
- 6 this part and it is alleged in the complaint and proved or admitted
- 7 at trial or ascertained by the court after conviction that the
- 8 person INDIVIDUAL had been previously convicted 2 times within the
- 9 preceding 5 years for a violation of this part or an order or
- 10 interim order issued under this part, the person-INDIVIDUAL is
- 11 guilty of a misdemeanor and shall be punished by imprisonment for
- 12 not less than 10 days or more than 180 days, and a fine of not less
- than \$500.00 or more than \$2,000.00, and costs of prosecution.
- 14 Enacting section 1. This amendatory act takes effect 90 days
- 15 after the date it is enacted into law.
- 16 Enacting section 2. This amendatory act does not take effect
