- 15 (d) Criminal justice information systems.
- 16 (e) Forensic analysis and biometric identification.
- 17 (f) General law enforcement and criminal investigations.
- 18 (q) Special operations.
- (h) Commercial vehicle regulation and enforcement.
- (i) Emergency management and homeland security.
- 21 (j) Highway safety planning.
- (k) Secondary road patrol program.
- 23 Sec. 222. The department shall notify the subcommittees, the
- 24 chairpersons of the senate and house standing committees on
- 25 appropriations, and the senate and house fiscal agencies not less
- 26 than 90 days before recommending to close or consolidate any state
- 27 police posts. The notification shall include a local and state

- 1 impact study of the proposed post closure or consolidation.
- 2 Sec. 223. At least 90 days before beginning any effort to
- 3 privatize, the department shall submit a complete project plan to
- 4 the subcommittees and the senate and house fiscal agencies. The
- 5 plan shall include the criteria under which the privatization
- 6 initiative will be evaluated. The evaluation shall be completed and
- 7 submitted to the subcommittees and the senate and house fiscal
- 8 agencies within 30 months.
- 9 Sec. 224. Funds appropriated in part 1 shall not be used by a
- 10 principal executive department, state agency, or authority to hire
- 11 a person to provide legal services that are the responsibility of
- 12 the attorney general. This prohibition does not apply to legal
- 13 services for bonding activities and for those outside services that
- 14 the attorney general authorizes.
- 15 Sec. 226. (1) When the department provides contractual
- 16 services to a local unit of government, the department shall be
- 17 reimbursed for all costs incurred in providing the services,
- 18 including, but not limited to, retirement and overtime costs.
- 19 (2) The department shall define service cost models for those
- 20 services requiring reimbursement.
- 21 (3) Contractual services provided to an entity other than a
- 22 local unit of government may be provided by department personnel,
- 23 but only on an overtime basis outside the normal work schedule of
- 24 the personnel.
- 25 (4) This section does not apply to services provided to state
- 26 agencies.
- Sec. 228. Not later than November 30, the state budget office

- 1 shall prepare and transmit a report that provides for estimates of
- 2 the total general fund/general purpose appropriations lapses at the
- 3 close of the prior fiscal year. This report shall summarize the
- 4 projected year-end general fund/general purpose appropriation
- 5 lapses by major departmental program or program areas. The report
- 6 shall be transmitted to the chairpersons of the senate and house
- 7 appropriations committees, the subcommittees, and the senate and
- 8 house fiscal agencies.
- 9 Sec. 229. Within 14 days after the release of the executive
- 10 budget recommendation, the department shall cooperate with the
- 11 state budget office to provide the senate and house appropriations
- 12 chairs, the subcommittees, and the senate and house fiscal agencies
- 13 with an annual report on estimated state restricted fund balances,
- 14 state restricted fund projected revenues, and state restricted fund
- 15 expenditures for the fiscal years ending September 30, 2016 and
- 16 September 30, 2017.
- 17 Sec. 230. The department shall maintain, on a publicly
- 18 accessible website, a department scorecard that identifies, tracks,
- 19 and regularly updates key metrics that are used to monitor and
- 20 improve the department's performance.
- 21 Sec. 232. The department shall serve as an active liaison
- 22 between the DTMB and state, local, regional, and federal public
- 23 safety agencies on matters pertaining to the Michigan public safety
- 24 communications system and shall report user issues to the DTMB.
- 25 Sec. 233. Total authorized appropriations from all sources
- 26 under part 1 for legacy costs for the fiscal year ending September
- 27 30, 2017 are \$133,307,100.00. From this amount, total agency

- 1 appropriations for pension-related legacy costs are estimated at
- 2 \$71,007,700.00. Total agency appropriations for retiree health care

- 4 Sec. 238. Money privately donated to the department is
- 5 appropriated under part 1 to be used for the purposes designated by
- 6 the donor of the money, if specified.
- 7 Sec. 240. In addition to the metrics required under section
- 8 447 of the management and budget act, 1984 PA 431, MCL 18.1447, for
- 9 each new program or program enhancement for which funds in excess
- 10 of \$500,000.00 are appropriated in part 1, the department shall
- 11 provide not later than November 1, 2016 a list of program-specific

- 21 community.
- 22 (2) The department shall provide performance data as provided
- 23 under section 219 for average classroom occupancy rate, with an
- 24 annual goal of at least 55%.
- 25 (3) The department shall submit a report to the subcommittees
- 26 and the senate and house fiscal agencies within 60 days of the

- 1 conclusion of any trooper, motor carrier, or state properties
- 2 security recruit school. The report shall include the following:
- 3 (a) The number of veterans and the number of MCOLES-certified
- 4 police officers who were admitted to and the number who graduated
- 5 from the recruit school.
- 6 (b) The total number of recruits who were admitted to the
- 7 school, the number of recruits who graduated from the school, and
- 8 the location at which each of these recruits is assigned.
- 9 (4) The department shall distribute and review course
- 10 evaluations to ensure that quality training is provided.
- 11 Sec. 402. (1) In accordance with applicable state and federal
- 12 laws and regulations, the department shall maintain and ensure
- 13 compliance with CJIS databases and applications in the support of
- 14 public safety and law enforcement communities.
- 15 (2) The department shall improve the accuracy, timeliness, and
- 16 completeness of criminal history information by conducting a
- 17 minimum of 30 outreach activities targeted to criminal justice
- 18 agencies.
- 19 (3) The department shall provide for the compilation of crime
- 20 statistics consistent with the uniform crime reporting (UCR)
- 21 program and the national incident-based report system (NIBRS).
- 22 (4) The department shall provide for the compilation and
- 23 evaluation of traffic crash reports and the maintenance of the
- 24 state accident data collection system.
- 25 (5) The department shall make traffic crash information
- 26 available to the public at a reasonable cost. For bulk access to
- 27 the accident records in which the vehicle identification number has

- 1 been collected and computerized, the department shall make those
- 2 records available to the public at cost, provided that the name and
- 3 address have been excluded.
- 4 (6) In accordance with applicable state and federal laws and
- 5 regulations, the department shall provide for the maintenance and
- 6 dissemination of criminal history records and juvenile records,
- 7 including to the extent necessary to exchange criminal history
- 8 records information with the Federal Bureau of Investigation and
- 9 other states through the interstate identification index, the
- 10 National Crime Information Center, and other federal CJIS databases
- 11 and indices.
- 12 (7) In accordance with applicable state and federal laws, the
- 13 department shall provide for the maintenance of records, including
- 14 criminal history records regarding firearms licensure.
- 15 (8) The department shall provide to the legislature a report
- 16 on concealed pistol licensing not later than December 1, 2017 that
- includes all of the following:
- 18 (a) The department's actual revenue received from fees paid
- 19 for concealed pistol license (CPL) applications for fiscal year
- 20 2016-2017 and the uses of that revenue.
- 21 (b) The department's fiscal year 2016-2017 costs for
- 22 administering its concealed pistol licensing responsibilities under
- 23 1927 PA 372, MCL 28.421 to 28.435, but not including costs related
- 24 to the administration of other state statutes, or requirements of
- 25 federal law.
- 26 (9) The department shall maintain the staff and resources
- 27 necessary to maintain the sex offender registry and enforce the

- 1 registration requirements as provided by law.
- 2 (10) The department shall provide information on the number of
- 3 background checks processed through the Internet criminal history
- 4 access tool (ICHAT) as provided in section 219.
- 5 (11) The following unexpended and unencumbered revenues
- 6 deposited into the criminal justice information service fee fund
- 7 shall not lapse to the general fund, but shall be carried forward
- 8 into the subsequent fiscal year:
- 9 (a) Fees for fingerprinting and criminal record checks and
- 10 name-based criminal record checks pursuant to 1935 PA 120, MCL
- **11** 28.271 to 28.273.
- 12 (b) Fees for application and licensing for initial and renewal
- 13 concealed pistol licenses pursuant to 1927 PA 372, MCL 28.421 to
- **14** 28.435.
- 15 (c) Fees for searching, copying, and providing public records
