## SUBSTITUTE FOR HOUSE BILL NO. 4508

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 7521 (MCL 333.7521), as amended by 2001 PA 236.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7521. (1) The following property is subject to
- 2 forfeiture:
- 3 (a) A prescription form, controlled substance, an imitation
- 4 controlled substance, a controlled substance analogue, or other
- 5 drug that has been manufactured, distributed, dispensed, used,
- 6 possessed, or acquired in violation of this article.
- 7 (b) A raw material, product, or equipment of any kind that is
- 8 used, or intended for use, in manufacturing, compounding,
- 9 processing, delivering, importing, or exporting a controlled
- 10 substance, a controlled substance analogue, or other drug in

- 1 violation of this article; or a raw material, product, or equipment
- 2 of any kind that is intended for use in manufacturing, compounding,
- 3 processing, delivering, importing, or exporting an imitation
- 4 controlled substance in violation of section 7341.
- 5 (c) Property that is used, or intended for use, as a container
- 6 for property described in subdivision (a) or (b).
- 7 (d) Except as provided in subparagraphs (i) to  $\frac{(iv)}{(iv)}$ , a
- 8 conveyance, including an aircraft, vehicle, or vessel used or
- 9 intended for use, to transport, or in any manner to facilitate the
- 10 transportation, for the purpose of sale or receipt of property
- 11 described in subdivision (a) or (b):
- (i) A conveyance used by a person as a common carrier in the
- 13 transaction of business as a common carrier is not subject to
- 14 forfeiture unless it appears that the owner or other person in
- 15 charge of the conveyance is a consenting party or privy to a
- 16 violation of this article.
- 17 (ii) A conveyance is not subject to forfeiture by reason of
- 18 any act or omission established by the owner of that conveyance to
- 19 have been committed or omitted without the owner's knowledge or
- 20 consent.
- 21 (iii) A conveyance is not subject to forfeiture for a
- 22 violation of section 7403(2)(c) or (d), section 7404, or section
- **23** 7341(4).
- 24 (iv) A forfeiture of a conveyance encumbered by a bona fide
- 25 security interest is subject to the interest of the secured party
- 26 who neither had knowledge of nor consented to the act or omission.
- 27 (v) A CONVEYANCE USED ONLY TO PURCHASE OR RECEIVE NOT MORE

- 1 THAN 1 OUNCE OF MARIHUANA FOR PERSONAL USE IS NOT SUBJECT TO
- 2 FORFEITURE. THIS SUBPARAGRAPH APPLIES TO PROCEEDINGS COMMENCED
- 3 UNDER THIS ARTICLE ON OR AFTER THE EFFECTIVE DATE OF THE AMENDATORY
- 4 ACT THAT ADDED THIS SUBPARAGRAPH.
- 5 (e) Books, records, and research products and materials,
- 6 including formulas, microfilm, tapes, and data used, or intended
- 7 for use, in violation of this article.
- 8 (f) Any thing of value that is furnished or intended to be
- 9 furnished in exchange for a controlled substance, an imitation
- 10 controlled substance, or other drug in violation of this article
- 11 that is traceable to an exchange for a controlled substance, an
- 12 imitation controlled substance, or other drug in violation of this
- 13 article or that is used or intended to be used to facilitate any
- 14 violation of this article including, but not limited to, money,
- 15 negotiable instruments, or securities. To the extent of the
- 16 interest of an owner, a thing of value is not subject to forfeiture
- 17 under this subdivision by reason of any act or omission that is
- 18 established by the owner of the item to have been committed or
- 19 omitted without the owner's knowledge or consent. Any money that is
- 20 found in close proximity to any property that is subject to
- 21 forfeiture under subdivision (a), (b), (c), (d), or (e) is presumed
- 22 to be subject to forfeiture under this subdivision. This
- 23 presumption may be rebutted by clear and convincing evidence.
- 24 (g) Any other drug paraphernalia not described in subdivision
- **25** (b) or (c).
- 26 (2) As used in this section, "imitation controlled substance"
- 27 means that term as defined in section 7341.
