SUBSTITUTE FOR HOUSE BILL NO. 5164

A bill to amend 1967 PA 288, entitled "Land division act,"

by amending section 241 (MCL 560.241), as amended by 1998 PA 549.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 241. (1) When a final plat is submitted to the clerk of
- 2 the governing body of the municipality, the proprietor shall
- 3 deposit with the plat both of the following:
- 4 (a) A filing and recording fee of \$20.00. IN AN AMOUNT EQUAL
- 5 TO THE FEE FOR ENTERING AND RECORDING A REAL ESTATE MORTGAGE UNDER
- 6 SECTION 2567 OF THE REVISED JUDICATURE ACT OF 1961, 1961 PA 236,
- 7 MCL 600.2567. The filing and recording fee is in addition to any
- 8 fee the municipality may charge under this act.
- 9 (b) A state plat review fee of \$150.00, plus \$15.00 for each
- 10 lot over 4 lots included in the plat. The state plat review fee

- 1 shall be paid by check or money order payable to the state of
- 2 Michigan.
- 3 (2) Upon approval of the plat by the governing body, the clerk
- 4 shall send the filing and recording fee and the state plat review
- 5 fee with the plat to the clerk of the county plat board.
- 6 (3) The clerk of the county plat board shall deposit the
- 7 filing and recording fee in the county trust and agency fund for
- 8 subsequent payment by county warrant from this fund to the county
- 9 register of deeds in the amount of \$20.00, THE FILING AND RECORDING
- 10 FEE, upon submission of proof to the clerk of the county plat board
- 11 that the plat has been recorded in the office of the county
- 12 register of deeds.
- 13 (4) If a final plat is forwarded to the state administrator,
- 14 the clerk of the county plat board shall forward the state plat
- 15 review fee with the plat.
- 16 (5) A state plat review fee collected by this state shall be
- 17 deposited in the state treasury for use in the administration of
- 18 this act. A fund in which state plat review fees shall be deposited
- 19 is created in the state treasury. This fund is a revolving fund,
- 20 and money remaining in the fund at the end of the fiscal year shall
- 21 be carried over in the fund to the next and succeeding fiscal years
- 22 for use in the administration of this act.
- 23 Enacting section 1. This amendatory act takes effect October
- **24** 1, 2016.
- 25 Enacting section 2. This amendatory act does not take effect
- 26 unless Senate Bill No. 599 of the 98th Legislature is enacted into
- 27 law.
