24 PROVISIONS CONCERNING APPROPRIATIONS

25 GENERAL SECTIONS

1 Sec. 201. In accordance with the provisions of section 30 of
2 article IX of the state constitution of 1963, total state spending
3 from state resources in this appropriation act for the fiscal year
4 ending September 30, 2016 is \$400.00 and state appropriations paid
5 to local units of government are \$200.00.

6 Sec. 202. The appropriations made and expenditures authorized
7 under this act and the departments, commissions, boards, offices,
8 and programs for which appropriations are made under this act are
9 subject to the management and budget act, 1984 PA 431, MCL 18.1101
10 to 18.1594.

11 CAPITAL OUTLAY

12 Sec. 301. The planning grant authorized in part 1 for the
13 Michigan state police Grand Rapids forensic laboratory, Rockford
14 post, and 6th district headquarters consolidation authorizes the
15 Michigan state police and the department of technology, management,
16 and budget to conduct a project planning study only. The planning
17 grant authorized in part 1 shall be supported solely from existing
18 appropriations to the departments of technology, management, and
19 budget and state police as authorized in 2015 PA 84 and shall not
20 exceed \$150,000.00 per department. The departments of technology,
21 management, and budget and state police shall present the completed
22 plan to the joint capital outlay subcommittee for review and
23 approval in accordance with the capital outlay process. If the
24 joint capital outlay subcommittee approves the project through an
25 affirmative vote, construction authorization shall be required in
26 an appropriation act prior to moving forward on the completed plan.
