## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7410. (1) Except as otherwise provided in subsections (2)
- 2 and (3), an individual 18 years of age or over who violates section
- 3 7401(2)(a)(iv) by delivering or distributing a controlled substance
- 4 listed in schedule 1 or 2 that is either a narcotic drug or
- described in section 7214(a)(iv) to an individual under 18 years of 5
- 6 age who is at least 3 years the deliverer's or distributor's junior
- 7 may be punished by the fine authorized by section 7401(2)(a)(iv) or
  - by a term of imprisonment of not less than 1 year nor more than
- twice that authorized by section 7401(2)(a)(iv), or both. An

- 7 LOCAL UNIT OF GOVERNMENT OR AUTHORITY OR COMBINATION OF LOCAL UNITS
- 8 OF GOVERNMENT AND AUTHORITIES; A COMMUNITY COLLEGE DISTRICT; A
- 9 COLLEGE OR UNIVERSITY; OR ANY PRIVATE LIBRARY OPEN TO THE PUBLIC.
- 10 (B) "SCHOOL PROPERTY" MEANS A BUILDING, PLAYING FIELD, OR
- 11 PROPERTY USED FOR SCHOOL PURPOSES TO IMPART INSTRUCTION TO CHILDREN
- 12 IN GRADES KINDERGARTEN THROUGH 12, WHEN PROVIDED BY A PUBLIC,
- 13 PRIVATE, DENOMINATIONAL, OR PAROCHIAL SCHOOL, EXCEPT THOSE
- 14 BUILDINGS USED PRIMARILY FOR ADULT EDUCATION OR COLLEGE EXTENSION

- 16 Enacting section 1. This amendatory act takes effect 90 days
- 17 after the date it is enacted into law.
