- 1 SEC. 59E. (1) IF A PUBLIC RECORD CONTAINS MATERIAL THAT IS NOT
- 2 EXEMPT UNDER SECTION 59D, AS WELL AS MATERIAL THAT IS EXEMPT FROM
- 3 DISCLOSURE UNDER SECTION 59D, THE PUBLIC BODY SHALL SEPARATE THE
- 4 EXEMPT AND NONEXEMPT MATERIAL AND MAKE THE NONEXEMPT MATERIAL
- 5 AVAILABLE FOR EXAMINATION AND COPYING.
- 6 (2) WHEN DESIGNING A PUBLIC RECORD, A PUBLIC BODY SHALL, TO
- 7 THE EXTENT PRACTICABLE, FACILITATE A SEPARATION OF EXEMPT FROM
