## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 5. (1) An applicant who chooses to apply for an enhanced

driver license or enhanced official state personal identification
card shall provide all of the following items to the secretary of
state in the manner prescribed by the secretary of state:

(a) A completed application indicating the applicant's full
legal name, any legal name change resulting from the applicant's
adoption, marriage, divorce, or a court order, date of birth,
residence address, height, gender, eye color, social security

number, signature, and, if applicable, the applicant's intention to

be an organ donor as provided under section 307 of the Michigan

- 3 (b) Documentation demonstrating the applicant's United States
- 4 citizenship, full legal name, any legal name change resulting from

- 7 (c) The applicant's signed certification that the information
- 8 presented by the applicant is true and correct to the best of the
- 9 applicant's knowledge.

- 11 (2) An applicant who applies for an enhanced driver license or
- 12 enhanced official state personal identification card shall have his
- 13 or her facial image and signature captured or reproduced by the

- 17 (a) By a federal, state, or local government agency for any
- 18 law enforcement purpose authorized by law.
- 19 (b) By another state to the extent required by federal law.
- (c) By the secretary of state for any purpose specifically

- 22 (D) BY THE SECRETARY OF STATE FOR FORWARDING TO THE DEPARTMENT

- 25 (E) (d)—For any other purpose as determined by the secretary
- 26 of state, if a person provides his or her written authorization for

- 2 (3) Except as otherwise provided under subsection (2), the
- 3 secretary of state shall not disclose a person's facial image,
- 4 signature, social security number, or copies or digital images of
- 5 documents retained under this act.
- 6 (4) An enhanced driver license or enhanced official state
- 7 personal identification card issued under this act shall not
- 8 display a person's social security number on the face of the card.
- 9 (5) The secretary of state shall examine and verify the
- 10 genuineness, regularity, and legality of every application and
- 11 other documentation submitted to the secretary of state for an
- 12 enhanced driver license or enhanced official state personal
- 13 identification card, and may in all cases investigate as the
- 14 secretary of state considers necessary or require additional
- 15 information, and shall reject any application if not satisfied of
- 16 the genuineness, regularity, and legality of the application or
- 17 supporting documentation or the truth of any statement contained in
- 18 the application or supporting documentation, or for any other
- 19 reason authorized by law. A decision by the secretary of state to
- 20 reject an application under this subsection may be appealed under

- 23 (6) The secretary of state shall retain copies or digital
- 24 images of documents provided by the applicant to the secretary of
- 25 state under this act.
- 26 (7) The facial image of an applicant for a license or card
- 27 under this act who was not issued an enhanced driver license or

- 1 enhanced official state personal identification card shall be
- 2 retained for not less than 1 year, unless fraud is suspected, in
- 3 which case a record containing the applicant's facial image and the
- 4 reason for denial shall be retained for not less than 10 years.
- 5 (8) The secretary of state may disclose digital images of
- 6 documents retained under this act to a federal, state, or local
- 7 government agency for any law enforcement purpose authorized by
- 8 law. Except as otherwise provided in this act, copies or digital
- 9 images of documents retained under this act are exempt from
- 10 disclosure under the freedom of information act, 1976 PA 442, MCL

- 12 (9) The secretary of state shall not compile or maintain a
- 13 database under this act that may be shared with a country other
- 14 than the United States.
- 15 Enacting section 1. This amendatory act takes effect 90 days
- 16 after the date it is enacted into law.
