## SUBSTITUTE FOR SENATE BILL NO. 84

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 811aa.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811AA. (1) NO LATER THAN OCTOBER 1, 2015, THE SECRETARY
- 2 OF STATE SHALL DEVELOP UNDER SECTION 811E AND ISSUE UNDER SECTION
- 3 811F A FUND-RAISING PLATE RECOGNIZING THE CHOOSE LIFE MICHIGAN
- 4 FUND. THE SECRETARY OF STATE, IN CONJUNCTION WITH THE BOARD OF THE
- 5 CHOOSE LIFE MICHIGAN FUND, SHALL DESIGN THE FUND-RAISING PLATES
- 6 AUTHORIZED IN THIS SECTION.
- 7 (2) THE CHOOSE LIFE FUND IS CREATED WITHIN THE STATE TREASURY.
- 8 THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS FROM ANY
- 9 SOURCE FOR DEPOSIT INTO THE FUND. THE STATE TREASURER SHALL DIRECT

- 1 THE INVESTMENT OF THE FUND. THE STATE TREASURER SHALL CREDIT TO THE
- 2 FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS. MONEY IN THE FUND
- 3 AT THE CLOSE OF THE FISCAL YEAR SHALL REMAIN IN THE FUND AND SHALL
- 4 NOT LAPSE TO THE GENERAL FUND.
- 5 (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY
- 6 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING THE CHOOSE LIFE
- 7 MICHIGAN FUND TO THE STATE TREASURER, WHO SHALL CREDIT THE DONATION
- 8 MONEY TO THE CHOOSE LIFE FUND CREATED UNDER SUBSECTION (2).
- 9 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE CHOOSE
- 10 LIFE FUND CREATED UNDER SUBSECTION (2) ON AN ANNUAL BASIS TO THE
- 11 CHOOSE LIFE MICHIGAN FUND.
- 12 (5) THE STATE TREASURER SHALL BE THE ADMINISTRATOR OF THE
- 13 CHOOSE LIFE FUND CREATED UNDER SUBSECTION (2) FOR AUDITING
- 14 PURPOSES.
- 15 (6) MONEY DISBURSED TO THE CHOOSE LIFE MICHIGAN FUND UNDER
- 16 THIS SECTION SHALL BE DISTRIBUTED TO ELIGIBLE NONPROFIT
- 17 ORGANIZATIONS THAT ARE EXEMPT FROM TAXATION UNDER SECTION 501(C)(3)
- 18 OF THE INTERNAL REVENUE CODE, 26 USC 501, TO BE EXPENDED ON
- 19 PROJECTS THAT PROMOTE ALTERNATIVES TO ABORTION. AS USED IN THIS
- 20 SUBSECTION:
- 21 (A) "ELIGIBLE NONPROFIT ORGANIZATIONS" INCLUDES, BUT IS NOT
- 22 LIMITED TO, CRISIS PREGNANCY CENTERS, HOMES FOR PREGNANT WOMEN, AND
- 23 OTHER ORGANIZATIONS THAT PROVIDE PRACTICAL SUPPORT TO PREGNANT
- 24 WOMEN, PROVIDE PRACTICAL OUTREACH TO AT-RISK POPULATIONS, AND
- 25 PROMOTE LIFE-SAVING PROGRAMS AND PROJECTS AS ALTERNATIVES TO
- 26 ABORTION.
- 27 (B) "PROJECTS THAT PROMOTE ALTERNATIVES TO ABORTION" INCLUDES,

- BUT IS NOT LIMITED TO, MEDIA CAMPAIGNS, SPECIALTY OUTREACHES TO AT-1
- RISK POPULATIONS, INCLUDING MINORITIES, TEENAGERS, COLLEGE-AGED 2
- WOMEN, POST-ABORTIVE WOMEN, AND CAMPAIGNS TO PROMOTE ADOPTION. 3
- Enacting section 1. This amendatory act takes effect 90 days
- after the date it is enacted into law. 5
