## **SENATE BILL No. 218**

March 18, 2015, Introduced by Senators SCHMIDT, JONES, HORN, BIEDA, KNEZEK, ANANICH, GREGORY, BRANDENBURG, ZORN, MACGREGOR, ROCCA, HOOD, NOFS, PROOS, SCHUITMAKER, CASPERSON, HILDENBRAND and O'BRIEN and referred to the Committee on Appropriations.

A bill to amend 2004 PA 46, entitled "Public safety officers benefit act," by amending the title and section 2 (MCL 28.632) and by adding section 4a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

TITLEAn act to provide compensation AND OTHER BENE

An act to provide compensation AND OTHER BENEFITS to dependents of public safety officers who are killed or who are permanently and totally disabled in the line of duty; to create the public safety officers benefit fund; to prescribe the duties and responsibilities of certain state officers; and to make an appropriation.

Sec. 2. As used in this act:

- 1 (a) "Commission" means the commission on law enforcement
- 2 standards created under the commission on law enforcement standards
- 3 act, 1965 PA 203, MCL 28.601 to 28.616.
- 4 (b) "Dependent" means any individual who was substantially
- 5 reliant for support upon the income of the deceased public safety

- 21 (f) "Line of duty" means either of the following:
- (i) Any action which an officer whose primary function is crime
- 23 control or reduction, enforcement of the criminal law, or
- 24 suppression of fires is obligated or authorized by rule,
- 25 regulations, condition of employment or service, or law to perform,
- 26 including those social, ceremonial, or athletic functions to which
- 27 the officer is assigned, or for which the officer is compensated,

- 19 (I) (h) "Permanent and total disability" means medically
- 20 determinable consequences of a catastrophic, line-of-duty injury
- 21 that permanently prevent a former public safety officer from
- 22 performing any gainful work.
- 23 (J) (i)—"Public safety officer" OR "OFFICER" means any
- 24 individual serving a public agency OR ANY AUTHORITY, DISTRICT,
- 25 BOARD, OR OTHER ENTITY CREATED IN WHOLE OR IN PART BY 1 OR MORE
- 26 CITIES, COUNTIES, VILLAGES, OR TOWNSHIPS, in an official capacity,
- 27 with or without compensation, as a law enforcement officer,

- 1 firefighter, rescue squad member, or ambulance crew member.OR
- 2 MEMBER OF A RESCUE SQUAD OR AMBULANCE CREW.
- 3 (K) (i) "Surviving spouse" means the husband or wife of the
- 4 deceased officer at the time of the officer's death, and includes a
- 5 spouse living apart from the officer at the time of the officer's
- 6 death for any reason.
- 7 SEC. 4A. (1) IF A PUBLIC SAFETY OFFICER DIES AS A DIRECT AND
- 8 PROXIMATE RESULT OF A PERSONAL INJURY SUSTAINED IN THE LINE OF DUTY
- 9 ON OR AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED
- 10 THIS SECTION, THIS STATE SHALL PROVIDE TO THE DECEDENT'S SURVIVING
- 11 SPOUSE AND DEPENDENT CHILDREN A COMPARABLE MEDICAL BENEFIT PLAN ON
- 12 COMPARABLE TERMS TO THE MEDICAL BENEFIT PLAN OFFERED TO MICHIGAN
- 13 STATE POLICE TROOPER RETIREES, INCLUDING ANY CHANGE TO THE MEDICAL
- 14 BENEFIT PLAN AFTER THE PUBLIC SAFETY OFFICER'S DEATH. COVERAGE
- 15 UNDER THIS SECTION IS NOT REQUIRED TO BE PROVIDED DURING ANY PERIOD
- 16 DURING WHICH THE SURVIVING SPOUSE OR DEPENDENT CHILD, RESPECTIVELY,
- 17 HAS QUALIFIED FOR AND IS COVERED BY A MEDICAL BENEFIT PLAN FROM
- 18 ANOTHER SOURCE. COVERAGE PROVIDED UNDER THIS SECTION ENDS FOR A
- 19 SURVIVING SPOUSE UPON MEDICARE ELIGIBILITY. COVERAGE FOR A
- 20 DEPENDENT CHILD IS NOT REQUIRED TO BE PROVIDED UNDER THIS SECTION
- 21 AFTER THE LIMITING AGE FOR A DEPENDENT CHILD OR ANOTHER TERMINATING
- 22 EVENT THAT IS PROVIDED IN THE MEDICAL BENEFIT PLAN FOR MICHIGAN

- 3 SECTION, WOULD RECEIVE BENEFITS UNDER A MEDICAL BENEFIT PLAN
- 4 THROUGH A RETIREMENT SYSTEM ADMINISTERED BY THIS STATE.
- 5 (3) THE OFFICE OF RETIREMENT SERVICES SHALL ADMINISTER
- 6 BENEFITS PROVIDED UNDER THIS SECTION. THE OFFICE OF RETIREMENT
- 7 SERVICES SHALL DETERMINE, IN ITS SOLE DISCRETION, IF A MEDICAL
- 8 BENEFIT PLAN IS COMPARABLE AND OFFERED ON COMPARABLE TERMS TO THE
- 9 MEDICAL BENEFIT PLAN OFFERED TO MICHIGAN STATE POLICE TROOPER
- 10 RETIRES FOR PURPOSES OF DETERMINING THE MEDICAL BENEFIT PLAN THAT
- 11 WILL BE OFFERED UNDER THIS SECTION.
- 12 (4) FOR PURPOSES OF THIS SECTION, "DEPENDENT CHILD" MEANS ANY
- 13 OF THE FOLLOWING DEPENDENTS WITH RESPECT TO THE DECEASED PUBLIC
- 14 SAFETY OFFICER:
- 15 (A) HIS OR HER UNMARRIED NATURAL OR ADOPTED CHILD.
- 16 (B) A CHILD LAWFULLY PLACED FOR ADOPTION WITH THE PUBLIC
- 17 SAFETY OFFICER.
- 18 (C) HIS OR HER STEPCHILD.
- 19 (D) A CHILD UNDER THE AGE OF 18 IF FULL LEGAL GUARDIANSHIP WAS
- 20 AWARDED TO THE PUBLIC SAFETY OFFICER.
- 21 (5) IF A DEPENDENT CHILD OF A DECEASED PUBLIC SAFETY OFFICER
- 22 IS RECEIVING COVERAGE UNDER THIS SECTION, A CHILD OF THE DEPENDENT
- 23 CHILD IS NOT ALSO A DEPENDENT CHILD FOR PURPOSES OF THIS SECTION.
