SUBSTITUTE FOR

SENATE BILL NO. 271

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding section 1014.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1014. (1) AN ON-PREMISES LICENSEE SHALL NOT SELL, OFFER
- 2 TO SELL, OR ADVERTISE THE SALE OF AN UNLIMITED QUANTITY OF
- 3 ALCOHOLIC LIQUOR AT A SPECIFIC PRICE UNLESS ALL OF THE FOLLOWING
- 4 CONDITIONS ARE MET:
- 5 (A) THE SALE, OFFER, OR ADVERTISEMENT IS IN CONNECTION WITH A
- 6 PRIVATE FUNCTION.
- 7 (B) THE ON-PREMISES LICENSEE HAS ENTERED INTO A WRITTEN
- 8 AGREEMENT WITH THE ORGANIZER OF THE PRIVATE FUNCTION STATING ALL OF
- 9 THE FOLLOWING:
- 10 (i) THE DATE AND TIME THE EVENT WILL BE HELD.
- 11 (ii) THE LOCATION OF THE EVENT.

- 1 (iii) THE TERMS UNDER WHICH ALCOHOL WILL BE SOLD AND SERVED
- 2 DURING THE EVENT.
- (C) THE ON-PREMISES LICENSEE MAKES AVAILABLE TO THE COMMISSION 3
- 4 AND LOCAL LAW ENFORCEMENT, ON NOTICE, THE WRITTEN AGREEMENT
- 5 DESCRIBED IN SUBDIVISION (B).
- 6 (2) AN ON-PREMISES LICENSEE SHALL NOT SELL, OFFER TO SELL, OR
- ADVERTISE THE SALE OF 2 OR MORE IDENTICAL DRINKS CONTAINING 7
- ALCOHOLIC LIOUOR TO AN INDIVIDUAL FOR THE INDIVIDUAL'S CONSUMPTION 8
- FOR 1 PRICE. IF 2 OR MORE IDENTICAL DRINKS CONTAINING ALCOHOLIC
- 10 LIQUOR ARE SERVED TO AN INDIVIDUAL AT 1 TIME, THE PRICE CHARGED FOR
- 11 THE SECOND AND EACH ADDITIONAL DRINK MUST BE THE SAME AS THE PRICE
- 12 CHARGED FOR THE FIRST DRINK.
- (3) AS USED IN THIS SECTION, "PRIVATE FUNCTION" MEANS AN EVENT 13
- THAT MEETS ALL OF THE FOLLOWING CONDITIONS: 14
- 15 (A) IT IS A PREARRANGED PRIVATE PARTY, PRIVATE FUNCTION, OR
- PRIVATE EVENT FOR A SPECIFIC SOCIAL OR BUSINESS OCCASION. 16
- 17 (B) ATTENDANCE IS ONLY BY INVITATION OR RESERVATION.
- (C) IT IS NOT OPEN TO THE GENERAL PUBLIC. 18
- 19 (D) THE GUESTS ARE SERVED IN AN OUTDOOR SERVICE AREA OR ROOM
- 20 THAT IS WELL-DEFINED AND CLEARLY MARKED AND DESIGNATED AND USED
- 21 EXCLUSIVELY FOR THE EVENT.
