by amending section 5 (MCL 211.905), as amended by 2004 PA 443.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 5. (1) Beginning in 1994 through 2002, the tax levied under this act shall be collected and distributed by the local tax collecting unit under the provisions of the general property tax act at the same time as other taxes levied by the local school district for school operating purposes. However, in each year after 1993 if a local school district is not going to levy a tax in that summer but levied a tax in the summer of 1993, and the local tax collecting unit in which the local school district is located is collecting a tax for any taxing unit in that summer, the local tax collecting unit shall collect within that local school district 1/2 of the tax under this act in that summer. - 16 into the state treasury to the credit of the state school aid fund.
- 17 Upon request by the local tax collecting unit, if the local tax

- 21 under this act, the state treasurer shall return to the local tax
- 22 collecting unit or to the school district or intermediate school
