

**SUBSTITUTE FOR
SENATE BILL NO. 910**

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 19601, 19607, 19608, and 19608a (MCL
324.19601, 324.19607, 324.19608, and 324.19608a), sections 19601
and 19607 as added by 1998 PA 288, section 19608 as amended by 2012
PA 446, and section 19608a as added by 2003 PA 253, and by adding
section 19608b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 19601. As used in this part:

2 **(A) "BASELINE ENVIRONMENTAL ASSESSMENT" MEANS THAT TERM AS**
3 **DEFINED IN SECTIONS 20101 AND 21302.**

4 **(B) ~~(a)~~"Bonds"** means the bonds authorized under the clean
5 Michigan initiative act, **1998 PA 284, MCL 324.95101 TO 324.95108.**

6 **(C) "BROWNFIELD PROJECT" OR "PROJECT" MEANS THE ENTIRE PROJECT**

1 TO BE UNDERTAKEN, INCLUDING, BUT NOT LIMITED TO, THE ACTUAL SITE
2 REMEDIATION AND ITS RESULTING ECONOMIC DEVELOPMENT.

3 (D) "CHIEF EXECUTIVE OFFICER" MEANS THE MAYOR OF A CITY, THE
4 VILLAGE MANAGER OF A VILLAGE, THE TOWNSHIP SUPERVISOR OF A
5 TOWNSHIP, OR THE COUNTY EXECUTIVE OF A COUNTY OR, IF THE COUNTY
6 DOES NOT HAVE AN ELECTED COUNTY EXECUTIVE, THE CHAIRPERSON OF THE
7 COUNTY BOARD OF COMMISSIONERS.

14 (H) "ELIGIBLE ACTIVITIES" FOR PROJECTS WITH FUNDING ALLOCATED
15 UNDER SECTION 19608 (1) (A) *(iv)* MEANS:

16 *(i)* BASELINE ENVIRONMENTAL ASSESSMENT ACTIVITIES.

17 *(ii)* INVESTIGATIONS.

18 *(iii)* DUE CARE ACTIVITIES.

19 *(iv)* RESPONSE ACTIVITIES, INCLUDING RESPONSE ACTIVITIES THAT
20 ARE MORE PROTECTIVE OF THE PUBLIC HEALTH, SAFETY, AND WELFARE AND
21 THE ENVIRONMENT THAN REQUIRED BY SECTION 20107A OR 21304C.

23 TO PARTS 211 AND 213.

24 *(vi)* DUST CONTROL RELATED TO CONSTRUCTION ACTIVITIES.

26 *(viii)* SHEETING AND SHORING NECESSARY FOR THE REMOVAL OF
27 MATERIALS EXCEEDING PART 201 CLEANUP CRITERIA AT PROJECTS REQUIRING

1 A PERMIT UNDER PART 301, 303, OR 325.

2 (ix) THE FOLLOWING ACTIVITIES, PROVIDED THAT THE TOTAL COST OF
3 THESE ACTIVITIES DOES NOT EXCEED THE TOTAL COST OF PROJECT-RELATED
4 ACTIVITIES IDENTIFIED IN SUBPARAGRAPHS (i) TO (viii) :

5 (A) DISPOSAL OF SOLID WASTE, AS DEFINED IN PART 115, FROM THE
6 ELIGIBLE PROPERTY, PROVIDED IT WAS NOT GENERATED OR ACCUMULATED BY
7 THE AUTHORITY OR THE DEVELOPER.

8 (B) LEAD, ASBESTOS, OR MOLD ABATEMENT, AND DEMOLITION OF
9 STRUCTURES THAT ARE NOT A RESPONSE ACTIVITY.

10 (C) REMOVAL AND DISPOSAL OF LAKE OR RIVER SEDIMENTS EXCEEDING
11 PART 201 UNRESTRICTED CRITERIA FROM, AT, OR RELATED TO AN ECONOMIC
12 DEVELOPMENT PROJECT IF THE UPLAND PROPERTY EITHER IS A FACILITY OR
13 WOULD BECOME A FACILITY AS A RESULT OF THE DEPOSITION OF DREDGED
14 SPOILS.

15 (I) "ELIGIBLE PROPERTY" FOR PROJECTS WITH FUNDING ALLOCATED
16 UNDER SECTION 19608(1) (A) (iv) MEANS PROPERTY THAT IS KNOWN OR
17 SUSPECTED TO BE A FACILITY UNDER PART 201 OR A SITE OR PROPERTY
18 UNDER PART 213 AND THAT WAS USED OR IS CURRENTLY BEING USED FOR
19 COMMERCIAL, INDUSTRIAL, PUBLIC, OR RESIDENTIAL PURPOSES.

20 (J) ~~(d)~~-"Facility" means that term as it is defined in part
21 201.

22 (K) ~~(e)~~-"Fund" means the clean Michigan initiative bond fund
23 created in section 19606.

24 (L) ~~(f)~~-"Gaming facility" means a gaming facility regulated
25 under the Michigan gaming control and revenue act, ~~the Initiated~~
26 ~~Law of 1996,~~ 1996 IL 1, MCL 432.201 to 432.226.

27 (M) ~~(g)~~-"Local unit of government" means a county, city,

1 village, or township, or an agency of a county, city, village, or
2 township; or **A BROWNFIELD REDEVELOPMENT AUTHORITY, ECONOMIC**
3 **DEVELOPMENT CORPORATION, OR** an authority or other public body
4 created by or pursuant to state law.

5 (N) **"MEASURABLE ECONOMIC BENEFIT" MEANS THE PERMANENT JOBS**
6 **THAT ARE CREATED OR RETAINED, THE CAPITAL INVESTED, OR THE**
7 **INCREASED TAX BASE TO THE APPLICABLE COUNTY, CITY, VILLAGE, AND**
8 **TOWNSHIP WHERE THE PROJECT IS LOCATED.**

9 (O) **"MEASURABLE ENVIRONMENTAL BENEFIT" MEANS THE EXTENT THAT**
10 **THE REQUIREMENTS OF PART 201 OR PART 213, OR BOTH, ARE ADVANCED AT**
11 **A BROWNFIELD PROJECT WHERE ENVIRONMENTAL CONDITIONS INHIBIT THE**
12 **SITE'S REDEVELOPMENT OR REUSE.**

13 (P) **"PART 213 PROPERTY" MEANS A PROPERTY AS DEFINED IN SECTION**
14 **21303.**

15 (Q) ~~(h)~~-"Response activity" means that term as it is defined
16 in part 201 **OR CORRECTIVE ACTION AS DEFINED IN PART 213.**

17 Sec. 19607. (1) The total proceeds of all bonds shall be
18 deposited into the fund and allocated as follows:

19 (a) Not more than \$335,000,000.00 shall be used for ~~response~~
20 **ELIGIBLE** activities at facilities **AND PART 213 PROPERTIES.**

21 (b) Not more than \$50,000,000.00 shall be used for waterfront
22 improvements.

23 (c) Not more than \$25,000,000.00 shall be used for remediation
24 of contaminated lake and river sediments.

25 (d) Not more than \$50,000,000.00 shall be used for nonpoint
26 source pollution prevention and control projects or wellhead
27 protection projects.

1 (e) Not more than \$90,000,000.00 shall be used for water
2 quality monitoring and water resources protection and pollution
3 control activities.

4 (f) Not more than \$20,000,000.00 shall be used for pollution
5 prevention programs.

6 (g) ~~Not~~ **EXCEPT AS PROVIDED UNDER SUBSECTION (1) (A)**, **NOT** more
7 than \$5,000,000.00 shall be used to abate lead hazards.

8 (h) Not more than \$50,000,000.00 shall be used for state park
9 infrastructure improvements.

10 (i) Not more than \$50,000,000.00 shall be used for local
11 recreation projects.

12 (2) The state treasurer shall direct the investment of the
13 fund. Except as may be required to maintain the exclusion from
14 gross income of the interest paid on the bonds or to comply
15 otherwise with state or federal law, interest and earnings from
16 investment of the proceeds of any bond issue shall be allocated in
17 the same proportion as earned on the investment of the proceeds of
18 the bond issue.

19 (3) Except as may be required to maintain the exclusion from
20 gross income of the interest paid on the bonds or to comply
21 otherwise with state or federal law, all repayments of principal
22 and interest earned under a loan program authorized by this part
23 shall be credited to the appropriate restricted subaccount of the
24 fund and used for the purposes authorized for that subaccount or to
25 pay debt service on any obligation issued which pledges the loan
26 repayments and the proceeds of which are deposited in that
27 subaccount.

1 (4) The bond proceeds shall be expended in an appropriate
2 manner that maintains the tax exempt status of the bonds.

3 (5) The unencumbered balance in the fund at the close of the
4 fiscal year shall remain in the fund and shall not revert to the
5 general fund.

6 (6) The department shall provide an annual accounting of bond
7 proceeds spending on a cash basis to the department of treasury in
8 order for the state to comply with requirements set forth for
9 issuing tax exempt bonds, including arbitrage rebate calculations.
10 This accounting shall be submitted to the governor, the standing
11 committees of the house of representatives and the senate that
12 primarily address issues pertaining to the protection of natural
13 resources and the environment, and the appropriations committees in
14 the house of representatives and the senate.

15 Sec. 19608. (1) Money in the fund that is allocated under
16 section 19607 shall be used for the following purposes:

17 (a) Money allocated under section 19607(1)(a) shall be used by
18 the department to fund all of the following:

19 (i) Corrective actions undertaken by the department to address
20 releases from leaking underground storage tanks pursuant to part
21 213.

22 (ii) Response activities undertaken by the department at
23 facilities pursuant to part 201 to address public health and
24 environmental problems or to promote redevelopment.

25 (iii) Assessment activities undertaken by the department to
26 determine whether a property is a facility.

27 (iv) \$75,000,000.00 shall be used to provide grants and loans

1 to local units of government ~~and brownfield redevelopment~~
2 ~~authorities created under the brownfield redevelopment financing~~
3 ~~act, 1996 PA 381, MCL 125.2651 to 125.2672, for response~~ **ELIGIBLE**
4 ~~activities at known or suspected facilities~~ **ELIGIBLE PROPERTIES**
5 with redevelopment potential. Of the money provided for in this
6 subparagraph, not more than \$50,000,000.00 shall be used to provide
7 grants and not more than \$25,000,000.00 shall be used to provide
8 loans pursuant to the clean Michigan initiative **GRANT AND** revolving
9 loan program created in section 19608a. However, grants or loans
10 provided for in this subparagraph shall not be made to a local unit
11 of government ~~or a brownfield redevelopment authority~~ that is
12 responsible for causing a release or threat of release under part
13 201 **OR PART 213** at the site proposed for grant or loan funding,
14 **EXCEPT AS PROVIDED IN SECTION 19608B(F)** .

15 (b) Money allocated under section 19607(1)(b) shall be used
16 for waterfront redevelopment grants pursuant to part 795.

17 (c) Money allocated under section 19607(1)(c) shall be used
18 for response activities for the remediation of contaminated lake
19 and river sediments pursuant to part 201.

20 (d) Money allocated under section 19607(1)(d) shall be used
21 for nonpoint source pollution prevention and control grants or
22 wellhead protection grants ~~pursuant to~~ **UNDER** part 88.

23 (e) Money allocated under section 19607(1)(e) shall be
24 deposited into the clean water fund created in section 8807.

25 (f) Money allocated under section 19607(1)(f) shall be
26 expended as follows:

27 (i) \$10,000,000.00 shall be deposited into the retired

1 engineers technical assistance program fund created in section
2 14512.

3 (ii) \$5,000,000.00 shall be deposited into the small business
4 pollution prevention assistance revolving loan fund created in
5 section 14513.

6 (iii) \$5,000,000.00 shall be used by the department to
7 implement pollution prevention activities other than those funded
8 under subparagraphs (i) and (ii).

9 (g) Money that is allocated under section 19607(1)(g) shall be
10 used by the department of ~~community health~~ **AND HUMAN SERVICES** for
11 remediation and physical improvements to structures to abate or
12 minimize exposure of persons to lead hazards.

13 (h) Money allocated under section 19607(1)(h) shall be used
14 for infrastructure improvements at Michigan state parks as
15 determined by the department of natural resources. The installation
16 or upgrade of drinking water systems or rest room facilities shall
17 be the first priority.

18 (i) Money allocated under section 19607(1)(i) shall be used to
19 provide grants to local units of government for local recreation
20 projects ~~pursuant to~~ **UNDER** part 716.

21 (2) Of the money allocated under section 19607(1)(a),
22 \$93,000,000.00 shall be used for facilities **OR PART 213 PROPERTIES**
23 that pose an imminent or substantial endangerment to the public
24 health, safety, or welfare, or to the environment. For purposes of
25 this subsection, facilities **OR PART 213 PROPERTIES** that pose an
26 imminent or substantial endangerment ~~shall include~~, but are not
27 limited to, those where public access poses hazards because of

1 potential exposure to chemicals or safety risks and where drinking
2 water supplies are threatened by contamination.

3 (3) Before expending any funds allocated under subsection
4 (1) (c) at ~~a site that is~~ an area of concern as designated by the
5 parties to the Great Lakes water quality agreement **OF 1978 AS**
6 **AMENDED BY PROTOCOL SIGNED SEPTEMBER 7, 2012**, the department shall
7 notify the public advisory council established to oversee that area
8 of concern regarding the development, implementation, and
9 evaluation of response activities to be conducted with money in the
10 fund at that area of concern.

13 (4) ~~(5)~~ Money ~~provided~~ in the fund may be used by the
14 department of treasury to pay for the cost of issuing bonds and by

16 department costs as provided in this subsection. Not more than 3%
17 of the total amount specified in section 19607(1) (a) to (f) shall
18 be available for appropriation to the department to pay its costs
19 directly associated with the completion of a project authorized by
20 section 19607(1) (a) to (f). Not more than 3% of the total amount
21 specified in section 19607(1) (h) and (i) shall be available for

11 (6) ~~(7)~~—The department, the department of natural resources,
12 and the department of ~~community~~ health **AND HUMAN SERVICES** shall
13 each submit annually a list of all projects that will be undertaken
14 by that department that are recommended to be funded under this
15 part. The list shall be submitted to the governor, the standing
16 committees of the house of representatives and the senate that
17 primarily address issues pertaining to the protection of natural
18 resources and the environment, and the appropriations committees in
19 the house of representatives and the senate. The list shall be
20 submitted to the legislative committees not later than February 15
21 of each year. This list shall also be submitted before any request
22 for supplemental appropriation of bond funds. For each eligible
23 project, the list shall include the nature of the eligible project;
24 the county in which the eligible project is located; an estimate of
25 the total cost of the eligible project; and other information
26 considered pertinent by the administering state department. A
27 project that is funded by a grant or loan with money from the fund

1 does not need to be included on the list submitted under this
2 subsection. However, money in the fund that is appropriated for
3 grants and loans shall not be encumbered or expended until the
4 administering state department has reported those projects that
5 have been approved for a grant or a loan to the standing committees
6 of the house of representatives and the senate that primarily
7 address issues pertaining to the protection of natural resources
8 and the environment and to the appropriations subcommittees in the

1 (2) GRANTS PROVIDED UNDER THE CLEAN MICHIGAN INITIATIVE GRANT
2 AND REVOLVING LOAN PROGRAM THAT ARE USED SOLELY TO DETERMINE
3 WHETHER A PROPERTY IS A SITE OR A FACILITY AND, IF SO, TO
4 CHARACTERIZE THE NATURE AND EXTENT OF THE CONTAMINATION BY MEANS OF
5 AN ASSESSMENT OR INVESTIGATION SHALL BE ISSUED ONLY IF ALL OF THE
6 FOLLOWING CONDITIONS ARE MET:

18 (A) THE APPLICANT DEMONSTRATES THAT THE PROPOSED PROJECT IS
19 IN, OR WILL RESULT IN, COMPLIANCE WITH ALL APPLICABLE STATE LAWS

21 (B) THE APPLICANT DEMONSTRATES TO THE DEPARTMENT THE
22 CAPABILITY TO CARRY OUT THE PROPOSED PROJECT.

23 (C) THE APPLICANT DEMONSTRATES TO THE DEPARTMENT THAT THERE IS
24 AN IDENTIFIABLE SOURCE OF FUNDS FOR THE FUTURE MAINTENANCE AND
25 OPERATION OF THE ACTIVITIES FUNDED WITH MONEY FROM THE FUND, IF
26 APPROPRIATE.
