

HOUSE SUBSTITUTE FOR  
SENATE BILL NO. 1075

A bill to amend 1994 PA 451, entitled  
"Natural resources and environmental protection act,"  
by amending sections 43532, 43533, and 43536 (MCL 324.43532,  
324.43533, and 324.43536), as amended by 2013 PA 108.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 43532. ~~(1) An individual 17 years of age or older shall~~  
2 ~~not take or possess an aquatic species, except aquatic insects, in~~  
3 ~~the waters over which this state has jurisdiction without a~~  
4 ~~license. The fee for a resident restricted fishing license is~~  
5 ~~\$15.00. The fee for a nonresident restricted fishing license is~~  
6 ~~\$34.00.~~  
7       ~~(2) A restricted fishing license entitles the licensee to take~~  
8 ~~and possess aquatic species as prescribed by law, other than trout,~~  
9 ~~salmon, lake sturgeon, lake herring, amphibians, reptiles, or~~

1 ~~crustaceans.~~

2 ~~—— (3) An individual under 17 years of age may take aquatic~~  
 3 ~~species in the waters over which this state has jurisdiction~~  
 4 ~~without a license. However, an individual under 17 years of age may~~  
 5 ~~obtain an all-species fishing license. The fee for a resident or~~  
 6 ~~nonresident who is under 17 years of age for an all-species fishing~~  
 7 ~~license is \$2.00. The department shall not sell or vendor the list~~  
 8 ~~of licensees under this subsection.~~

9 ~~—— (4) The fee for a resident all-species fishing license is~~  
 10 ~~\$28.00. The fee for a nonresident all-species fishing license is~~  
 11 ~~\$42.00.~~

12 (1) ~~(5)~~ An all-species fishing license entitles the licensee  
 13 to take and possess all aquatic species as prescribed by law.

14 ~~—— (6) An individual to whom a valid restricted fishing license~~  
 15 ~~has been issued may return the restricted license to the department~~  
 16 ~~or its authorized agent and receive an all-species fishing license~~  
 17 ~~by paying a fee equal to the difference in cost between the all-~~  
 18 ~~species fishing license and the restricted fishing license for~~  
 19 ~~which that individual is eligible.~~

20 (2) ~~(7) Beginning March 1, 2014, an~~ **AN** individual 17 years of  
 21 age or older shall not take or possess an aquatic species, except  
 22 aquatic insects, in the waters over which this state has  
 23 jurisdiction without a license. The fee for a resident all-species  
 24 fishing license is \$25.00. The fee for a nonresident all-species  
 25 fishing license is \$75.00. ~~Beginning March 1, 2014, the restricted~~  
 26 ~~fishing license, license for an individual under 17 years of age,~~  
 27 ~~and all-species upgrades under subsections (1), (3), and (6) are no~~

1 ~~longer available.~~

2 (3) NOT LATER THAN MARCH 1, 2018, THE DEPARTMENT SHALL DEVELOP  
3 AN ELECTRONIC LICENSE THAT ALLOWS AN INDIVIDUAL TO DISPLAY AN  
4 ELECTRONIC COPY OF HIS OR HER ALL-SPECIES FISHING LICENSE USING AN  
5 ELECTRONIC DEVICE.

6 Sec. 43533. ~~(1) A resident or nonresident may purchase a 24-~~  
7 ~~hour or 72-hour fishing license entitling that individual to take,~~  
8 ~~for a designated 24-hour or 72-hour period, respectively, and~~  
9 ~~possess all aquatic species as prescribed by law. Except as~~  
10 ~~provided in this section, the fee for a 24-hour fishing license is~~  
11 ~~\$7.00 per designated consecutive 24-hour period. Notwithstanding~~  
12 ~~any other provision of this section, the fee for a 24-hour fishing~~  
13 ~~license for a senior citizen is \$3.00.~~

14 ~~—— (2) The fee for a 72-hour fishing license, to be issued~~  
15 ~~beginning in 2010, is as follows:~~

16 ~~—— (a) Except for a senior citizen, \$21.00.~~

17 ~~—— (b) For a senior citizen, \$9.00.~~

18 (1) ~~(3) Beginning March 1, 2014, a~~ **A** resident or nonresident  
19 may purchase a 24-hour fishing license entitling that individual to  
20 take, for a designated 24-hour period, and possess all aquatic  
21 species as prescribed by law. The fee for a 24-hour fishing license  
22 is \$10.00 per designated consecutive 24-hour period.

23 (2) ~~(4) Beginning March 1, 2014, a~~ **A** resident or nonresident  
24 may purchase a 72-hour fishing license entitling that ~~person~~  
25 **INDIVIDUAL** to take, for a designated 72-hour period, and possess  
26 all aquatic species as prescribed by law. The fee for a 72-hour  
27 fishing license is \$30.00 per designated consecutive 72-hour

1 period.

2           **(3) NOT LATER THAN MARCH 1, 2018, THE DEPARTMENT SHALL DEVELOP**  
3 **AN ELECTRONIC LICENSE THAT ALLOWS AN INDIVIDUAL TO DISPLAY AN**  
4 **ELECTRONIC COPY OF HIS OR HER 24-HOUR OR 72-HOUR FISHING LICENSE**  
5 **USING AN ELECTRONIC DEVICE.**

6           Sec. 43536. ~~(1) Until March 1, 2014, a resident of this state~~  
7 ~~who is 65 years of age or older may obtain a senior restricted~~  
8 ~~fishing license. The fee for a senior restricted fishing license is~~  
9 ~~discounted 60% from the fee for a resident restricted fishing~~  
10 ~~license.~~

11           **(1) (2)** A resident of this state who is 65 years of age or  
12 older may obtain a senior all-species fishing license. The fee for  
13 a senior all-species fishing license is discounted 60% from the fee  
14 for a resident all-species fishing license.

15           **(2) NOT LATER THAN MARCH 1, 2018, THE DEPARTMENT SHALL DEVELOP**  
16 **AN ELECTRONIC LICENSE THAT ALLOWS AN INDIVIDUAL TO DISPLAY AN**  
17 **ELECTRONIC COPY OF HIS OR HER SENIOR ALL-SPECIES FISHING LICENSE**  
18 **USING AN ELECTRONIC DEVICE.**

19           Enacting section 1. This amendatory act does not take effect  
20 unless Senate Bill No. 1073 of the 98th Legislature is enacted into  
21 law.
