A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 811bb.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811BB. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
- 2 SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE
- 3 RECOGNIZING THE ARTS. THE SECRETARY OF STATE IN CONJUNCTION WITH
- 4 THE MICHIGAN COUNCIL FOR THE ARTS AND CULTURAL AFFAIRS SHALL DESIGN
- 5 THE FUND-RAISING PLATE AUTHORIZED IN THIS SECTION.
- 6 (2) THE ARTS FUND IS CREATED WITHIN THE STATE TREASURY. THE
 - STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS FROM ANY SOURCE
 - FOR DEPOSIT INTO THE FUND. THE STATE TREASURER SHALL DIRECT THE
- 9 INVESTMENT OF THE FUND. THE STATE TREASURER SHALL CREDIT TO THE
- 10 FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS. MONEY IN THE FUND
- 11 AT THE CLOSE OF THE FISCAL YEAR SHALL REMAIN IN THE FUND AND SHALL

- 1 NOT LAPSE TO THE GENERAL FUND.
- 2 (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY
- 3 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING THE ARTS TO THE
- 4 STATE TREASURER, WHO SHALL CREDIT THE DONATION MONEY TO THE ARTS
- 5 FUND ESTABLISHED UNDER SUBSECTION (2).
- 6 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE ARTS FUND
