A bill to amend 1976 PA 451, entitled "The revised school code," by amending section 1166 (MCL 380.1166).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1166. (1) In all public and nonpublic schools in this
- 2 state regular courses of instruction shall be given in the
- 3 constitution of the United States, in the constitution of Michigan,
- 4 and in the history and present form of government of the United
- 5 States, Michigan, and its political subdivisions. Instruction shall
- begin not later than the opening of the eighth grade, or its
- 7 equivalent, except in schools maintaining a junior high school, in
 - which case it may begin in the ninth grade.
 - (2) A high school in this state which offers 12 grades shall

- 1 require a 1-semester course of study of 5 periods per week in
- 2 civics. which THE COURSE shall include the form and functions of
- 3 the federal, state, and local governments and shall stress the
- 4 rights and responsibilities of citizens. A diploma shall not be
- 5 issued by a high school to a pupil who has not successfully
- 6 completed this course, INCLUDING MEETING THE REQUIREMENTS OF
- 7 SUBSECTION (3). This COURSE requirement shall not be applicable as
