THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 377D. (1) A PERSON WHO WILLFULLY AND MALICIOUSLY DAMAGES,
- 2 DESTROYS, INJURES, DEFACES, DISMANTLES, OR REMOVES A TRAFFIC
- 3 CONTROL DEVICE, LIGHT POST, SIGN, OR OTHER DEVICE PLACED BY THIS
- 4 STATE OR BY A LOCAL UNIT OF GOVERNMENT OF THIS STATE FOR THE
- 5 PURPOSE OF REGULATING VEHICLE TRAFFIC, MAINTAINING HIGHWAY SAFETY,
- 6 OR PROVIDING INFORMATION TO MOTOR VEHICLE OPERATORS IS GUILTY OF A
- 7 CRIME AS FOLLOWS:
- 8 (A) EXCEPT AS PROVIDED IN SUBDIVISIONS (B) AND (C), THE PERSON
- 9 IS GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE
- 10 THAN 1 YEAR OR A FINE OF NOT MORE THAN \$500.00, OR BOTH.
