A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending section 502c (MCL 750.502c), as amended by 1998 PA 38.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 502c. (1) A person who is an owner, lessee, proprietor,

2 manager, superintendent, agent, or employee of any place of public or private housing, accommodation, amusement, or recreation, 3 4 including but not limited to any inn, hotel, motel, apartment 5 building, trailer park, restaurant, barbershop, billiard parlor, 6 store, public conveyance on AIR, land, or water, theater, motion 7 picture house, public or private educational institution, or 8 elevator, who refuses to permit a person with disabilities to enter or use the place when the place is available because the person 10 with disabilities is being led or accompanied by a guide or leader 11 dog, hearing dog, or service dog is guilty of a misdemeanor if the

- 1 quide or leader dog is wearing a harness or if the hearing dog or
- 2 service dog is wearing a blaze orange leash and collar, hearing dog
- 3 cape, or service dog backpack, and the person with disabilities
- 4 being led or accompanied has in his or her possession a pictured
- 5 identification card certifying that the dog was trained by a
- 6 qualified organization or trainer. The department of labor_CIVIL
- 7 RIGHTS shall maintain a list of organizations or trainers that
- 8 train guide or leader dogs, hearing dogs, and service dogs.
- 9 (2) A person who is an owner, lessee, proprietor, manager,
- 10 superintendent, agent, or employee of any place of public or
- 11 private housing, accommodation, amusement, or recreation,
- 12 including, but not limited to, the places listed in subsection (1),
- 13 who refuses to permit a trainer of guide or leader dogs, hearing
- 14 dogs, or service dogs to enter or use the place when the place is
- 15 available because the trainer is being led or accompanied by a
- 16 guide or leader dog, hearing dog, or service dog is guilty of a
- 17 misdemeanor if the guide or leader dog is wearing a harness or if
- 18 the hearing dog or service dog is wearing a hearing dog cape or
- 19 service dog backpack, if the trainer is being led or accompanied by
- 20 an adult dog for the purpose of training the dog, and if the
- 21 trainer has in his or her possession picture identification and
- 22 identification stating that he or she is a representative or
- 23 employee of an organization or trainer, or is a trainer, included
- 24 on the department of labor CIVIL RIGHTS list of organizations or
- 25 trainers that train guide or leader dogs, hearing dogs, or service
- 26 dogs.
- 27 (3) As used in this section:

- 1 (a) "Adult dog" means a domestic dog of the species canis
- 2 familiaris that is 12 months of age or older.
- 3 (b) "Audibly impaired" means audibly impaired THAT TERM as
- 4 defined in section 1 of 1981 PA 82, MCL 752.61.
- 5 (c) "Blind person" means a blind person THAT TERM as defined
- 6 in section 1 of 1978 PA 260, MCL 393.351.
- 7 (d) "Deaf person" means a deaf person THAT TERM as defined in
- 8 section 1 of 1981 PA 82, MCL 752.61.
- 9 (e) "Person with disabilities" means a person who is MEETS 1
- 10 OR MORE OF THE FOLLOWING CONDITIONS:
- 11 (i) IS audibly impaired, IS A blind PERSON, IS A deaf PERSON,
- 12 or IS otherwise physically limited.
- 13 (ii) IS A VETERAN WHO HAS BEEN DIAGNOSED WITH 1 OR MORE OF THE
- 14 FOLLOWING:
- 15 (A) SYMPTOMS ASSOCIATED WITH POST-TRAUMATIC STRESS DISORDER.
- 16 (B) SYMPTOMS ASSOCIATED WITH TRAUMATIC BRAIN INJURY.
- 17 (C) OTHER SERVICE-RELATED DISABILITIES.
- 18 (f) "Physically limited" means physically limited THAT TERM as
- 19 defined in section 1 of 1966 PA 1, MCL 125.1351.
- 20 (G) "VETERAN" MEANS ANY OF THE FOLLOWING:
- 21 (i) A PERSON WHO SERVED ON ACTIVE DUTY IN THE ARMED FORCES FOR
- 22 A PERIOD OF MORE THAN 180 DAYS AND SEPARATED FROM THE ARMED FORCES
- 23 IN A MANNER OTHER THAN A DISHONORABLE DISCHARGE.
- 24 (ii) A PERSON DISCHARGED OR RELEASED FROM ACTIVE DUTY BECAUSE
- 25 OF A SERVICE-RELATED DISABILITY.
- 26 (iii) A MEMBER OF A RESERVE BRANCH OF THE ARMED FORCES AT THE
- 27 TIME HE OR SHE WAS ORDERED TO ACTIVE DUTY DURING A PERIOD OF WAR,

- 1 OR IN A CAMPAIGN OR EXPEDITION FOR WHICH A CAMPAIGN BADGE IS
- 2 AUTHORIZED, AND WAS RELEASED FROM ACTIVE DUTY IN A MANNER OTHER
- 3 THAN A DISHONORABLE DISCHARGE.
