## **HOUSE BILL No. 4387**

March 24, 2015, Introduced by Rep. Yanez and referred to the Committee on Insurance.

A bill to amend 1976 PA 267, entitled "Open meetings act,"

by amending sections 2 and 3 (MCL 15.262 and 15.263), section 2 as amended by 2001 PA 38 and section 3 as amended by 1988 PA 278.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Public body" means any state or local legislative or
- 3 governing body, including a board, commission, committee,
- 4 subcommittee, authority, or council, that is empowered by state
- 5 constitution, statute, charter, ordinance, resolution, or rule to
- 6 exercise governmental or proprietary authority or perform a
- 7 governmental or proprietary function; a lessee of such a body
- 8 performing an essential public purpose and function pursuant to the
  - lease agreement; or the board of a nonprofit corporation formed by

- 1 a city under section 40 of the home rule city act, 1909 PA 279, MCL
- 2 117.40; OR THE CATASTROPHIC CLAIMS ASSOCIATION CREATED IN SECTION
- 3 3104 OF THE INSURANCE CODE OF 1956, 1956 PA 218, MCL 500.3104.
- 4 (b) "Meeting" means the convening of a public body at which a
- 5 quorum is present for the purpose of deliberating toward or
- 6 rendering a decision on a public policy, or any meeting of the
- 7 board of a nonprofit corporation formed by a city under section 40
- 8 of the home rule city act, 1909 PA 279, MCL 117.40, OR A MEETING OF
- 9 THE CATASTROPHIC CLAIMS ASSOCIATION CREATED IN SECTION 3104 OF THE
- 10 INSURANCE CODE OF 1956, 1956 PA 218, MCL 500.3104.
- 11 (c) "Closed session" means a meeting or part of a meeting of a
- 12 public body that is closed to the public.
- (d) "Decision" means a determination, action, vote, or
- 14 disposition upon a motion, proposal, recommendation, resolution,
- 15 order, ordinance, bill, or measure on which a vote by members of a
- 16 public body is required and by which a public body effectuates or
- 17 formulates public policy.
- 18 Sec. 3. (1) All meetings of a public body shall MUST be open
- 19 to the public and shall MUST be held in a place available to the
- 20 general public. All persons shall MUST be permitted to attend any
- 21 meeting except as otherwise provided in this act. The right of a
- 22 person to attend a meeting of a public body includes the right to
- 23 tape-record, to videotape, to broadcast live on radio, and to
- 24 telecast live on television the proceedings of a public body at a
- 25 public meeting. The exercise of this right shall not be dependent
- 26 upon the prior approval of the public body. However, a public body
- 27 may establish reasonable rules and regulations in order to minimize

- 1 the possibility of disrupting the meeting.
- 2 (2) All decisions of a public body shall be made at a meeting
- 3 open to the public.
- 4 (3) All deliberations of a public body constituting a quorum
- 5 of its members shall take place at a meeting open to the public
- 6 except as provided in this section and sections 7 and 8.
- 7 (4) A person shall not be required as a condition of
- 8 attendance at a meeting of a public body to register or otherwise
- 9 provide his or her name or other information or otherwise to
- 10 fulfill a condition precedent to attendance.
- 11 (5) A person shall be permitted to address a meeting of a
- 12 public body under rules established and recorded by the public
- 13 body. The legislature or a house of the legislature may provide by
- 14 rule that the right to address may be limited to prescribed times
- 15 at hearings and committee meetings only.
- 16 (6) A person shall not be excluded from a meeting otherwise
- 17 open to the public except for a breach of the peace actually
- 18 committed at the meeting.
- 19 (7) This act does not apply to the following public bodies
- 20 only when deliberating the merits of a case:
- 21 (a) The worker's compensation appeal board created under the
- 22 worker's disability compensation act of 1969, Act No. 317 of the
- 23 Public Acts of 1969, as amended, being sections 418.101 to 418.941
- 24 of the Michigan Compiled Laws.1969 PA 317, MCL 418.101 TO 418.941.
- 25 (b) The employment security board of review created under the
- 26 Michigan employment security act, Act No. 1 of the Public Acts of
- 27 the Extra Session of 1936, as amended, being sections 421.1 to

- 1 421.73 of the Michigan Compiled Laws.1936 (EX SESS) PA 1, MCL 421.1
- 2 TO 421.75.
- 3 (c) The state tenure commission created under Act No. 4 of the
- 4 Public Acts of the Extra Session of 1937, as amended, being
- 5 sections 38.71 to 38.191 of the Michigan Compiled Laws, 1937 (EX
- 6 SESS) PA 4, MCL 38.71 TO 38.191, when acting as a board of review
- 7 from the decision of a controlling board.
- 8 (d) An arbitrator or arbitration panel appointed by the
- 9 employment relations commission under the authority given the
- 10 commission by Act No. 176 of the Public Acts of 1939, as amended,
- 11 being sections 423.1 to 423.30 of the Michigan Compiled Laws.1939
- 12 PA 176, MCL 423.1 TO 423.30.
- 13 (e) An arbitration panel selected under chapter 50A of the
- 14 revised judicature act of 1961, Act No. 236 of the Public Acts of
- 15 1961, being sections 600.5040 to 600.5065 of the Michigan Compiled
- 16 Laws.
- 17 (E) (f) The Michigan public service commission created under
- 18 Act No. 3 of the Public Acts of 1939, being sections 460.1 to 460.8
- 19 of the Michigan Compiled Laws. 1939 PA 3, MCL 460.1 TO 460.11.
- 20 (F) THE CATASTROPHIC CLAIMS ASSOCIATION CREATED UNDER SECTION
- 21 3104 OF THE INSURANCE CODE OF 1956, 1956 PA 218, MCL 500.3104.
- 22 (8) This EXCEPT FOR THE CATASTROPHIC CLAIMS ASSOCIATION
- 23 CREATED IN SECTION 3104 OF THE INSURANCE CODE OF 1956, 1956 PA 218,
- 24 MCL 500.3104, THIS act does not apply to an association of insurers
- 25 created under the insurance code of 1956, Act No. 218 of the Public
- 26 Acts of 1956, being sections 500.100 to 500.8302 of the Michigan
- 27 Compiled Laws, 1956 PA 218, MCL 500.100 TO 500.8302, or other

- 1 association or facility formed under Act No. 218 of the Public Acts
- 2 of 1956 THE INSURANCE CODE OF 1956, 1956 PA 218, MCL 500.100 TO
- 3 500.8302, as a nonprofit organization of insurer members.
- 4 (9) This act does not apply to a committee of a public body
- 5 which THAT adopts a nonpolicymaking resolution of tribute or
- 6 memorial which resolution is not adopted at a meeting.
- 7 (10) This act does not apply to a meeting which THAT is a
- 8 social or chance gathering or conference not designed to avoid this
- 9 act.
- 10 (11) This act shall—DOES not apply to the Michigan veterans'
- 11 trust fund board of trustees or a county or district committee
- 12 created under Act No. 9 of the Public Acts of the First Extra
- 13 Session of 1946, being sections 35.601 to 35.610 of the Michigan
- 14 Compiled Laws, 1946 (1ST EX SESS) PA 9, MCL 35.602 TO 35.610, when
- 15 the board of trustees or county or district committee is
- 16 deliberating the merits of an emergent need. A decision of the
- 17 board of trustees or county or district committee made under this
- 18 subsection shall be reconsidered by the board or committee at its
- 19 next regular or special meeting consistent with the requirements of
- 20 this act. "Emergent need" means a situation which THAT the board of
- 21 trustees, by rules promulgated under the administrative procedures
- 22 act of 1969, Act No. 306 of the Public Acts of 1969, as amended,
- 23 being sections 24.201 to 24.328 of the Michigan Compiled Laws, 1969
- 24 PA 306, MCL 24.201 TO 24.328, determines requires immediate action.
- 25 Enacting section 1. This amendatory act does not take effect
- 26 unless Senate Bill No. or House Bill No. 4386 (request no.
- 27 00861'15) of the 98th Legislature is enacted into law.
