## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 16185A. (1) AN INDIVIDUAL MAY PRACTICE A HEALTH
- 2 PROFESSION AT A FREE MEDICAL CLINIC IN THIS STATE WITHOUT BEING
- 3 LICENSED UNDER THIS ACT IF ALL OF THE FOLLOWING REQUIREMENTS ARE
- 4 MET:
- 5 (A) THE INDIVIDUAL IS LICENSED OR OTHERWISE AUTHORIZED TO
  - PRACTICE A HEALTH PROFESSION BY ANY STATE OF THE UNITED STATES.
  - (B) THE INDIVIDUAL RESTRICTS HIS OR HER PRACTICE IN THIS STATE
  - SOLELY TO THE PROVISION OF CARE OR SERVICES WITHOUT CHARGE OR
- 9 REMUNERATION AT A FREE MEDICAL CLINIC.
  - (C) THE INDIVIDUAL PROVIDES ONLY THE CARE OR SERVICES THAT HE
