

# HOUSE BILL No. 4466

April 16, 2015, Introduced by Reps. Chang, Gay-Dagnogo, Geiss, Irwin, Love, Hovey-Wright, Guerra, Santana, Banks and Garrett and referred to the Committee on Criminal Justice.

A bill to amend 1968 PA 319, entitled

"An act to provide a uniform crime reporting system; to provide for the submitting of such report to the department of state police; to require submission of the report by certain police agencies; to require the reporting on wanted persons and stolen vehicles; to require the reporting of information regarding certain persons and unidentified bodies of deceased persons; to prescribe certain powers and duties of law enforcement agencies; and to vest the director of the department of state police with certain authority,"

by amending section 1 (MCL 28.251).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 1. (1) The police department of each city or village, any  
2           duly constituted police department of a township, and the sheriff's  
3           department of each county, once each month upon a date and form  
4           prescribed and furnished by the director of the department of state  
5           police, shall forward to the department of state police a crime  
6           report. Each reporting department shall report only on cases within  
7           its jurisdiction and upon which it is making, or has made, the

1 primary police investigation. The report shall be called the  
2 uniform crime report and shall cover crimes reported and otherwise  
3 processed during the month preceding the month of the report. ~~It~~  
4 **THE REPORT** shall contain the number and nature of offenses  
5 committed, the disposition of ~~such~~**THOSE** offenses, and ~~such~~**ANY**  
6 other information as the director of state police ~~shall specify~~  
7 **SPECIFIES** relating to the method, frequency, cause, and prevention  
8 of crime. Under no circumstances shall the name of any person be  
9 reported.

10 (2) IN ADDITION TO THE INFORMATION DESCRIBED IN SUBSECTION  
11 (1), THE REPORT SHALL INCLUDE ALL OF THE FOLLOWING:

12 (A) THE NUMBER AND TYPE OF USE OF FORCE COMPLAINTS MADE  
13 AGAINST OFFICERS OF THE DEPARTMENT SUBMITTING THE REPORT.

14 (B) THE NUMBER OF SHOOTING INCIDENTS INVOLVING OFFICERS OF THE  
15 DEPARTMENT SUBMITTING THE REPORT.

16 (C) THE DISPOSITION OF ALL INVESTIGATIONS INTO USE OF FORCE  
17 COMPLAINTS AGAINST, AND SHOOTING INCIDENTS INVOLVING, OFFICERS OF  
18 THE DEPARTMENT SUBMITTING THE REPORT.

19 (D) THE RACIAL, ETHNIC, AND GENDER DEMOGRAPHIC DATA OF  
20 INDIVIDUALS WHO MAKE USE OF FORCE COMPLAINTS AGAINST OFFICERS OF  
21 THE DEPARTMENT SUBMITTING THE REPORT.

22 (E) THE RACIAL, ETHNIC, AND GENDER DEMOGRAPHIC DATA OF  
23 INDIVIDUALS WHO ARE INVOLVED IN SHOOTING INCIDENTS INVOLVING  
24 OFFICERS OF THE DEPARTMENT SUBMITTING THE REPORT.

25 Enacting Section 1. This amendatory act takes effect 90 days  
26 after the date it is enacted into law.
