## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1035. (1) SUBJECT TO SUBSECTION (2), UNLESS BOTH PARTIES
- 2 TO A DOMESTIC RELATIONS ACTION STIPULATE TO MEDIATION, A COURT
- 3 SHALL NOT ORDER MEDIATION IN THE ACTION IF 1 OR MORE OF THE
- 4 FOLLOWING APPLY:
- 5 (A) A PERSONAL PROTECTION ORDER HAS BEEN ISSUED UNDER SECTION 6 2950 OR 2950A PROTECTING 1 PARTY AND RESTRAINING THE OTHER PARTY.
- 7 (B) A COURT ORDER PROHIBITING 1 OF THE PARTIES FROM CONTACTING
- 8 THE OTHER PARTY, OTHER THAN AN ORDER DESCRIBED IN SUBDIVISION (A),
- 9 HAS BEEN ENTERED.
- 10 (C) ONE OF THE PARTIES HAS ENGAGED IN CONDUCT PROHIBITED UNDER

- 26 (i) THE CUSTODY OF A MINOR.
- 27 (ii) PARENTING TIME WITH A MINOR.
