April 21, 2015, Introduced by Reps. Kesto, Kosowski, Kivela, Heise, Glardon, Faris, Hughes, Glenn, Price, Lyons, Cox and Geiss and referred to the Committee on Criminal Justice.

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

by amending sections 227 and 316 (MCL 600.227 and 600.316).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 227. (1) All writs and process issuing out of the supreme
- 2 court shall be styled: "In the Name of the People of the State of
- 3 Michigan, " and shall run into and MAY be executed in any county of
- 4 the THIS state. The seal of the supreme court affixed to, or
- 5 impressed upon, ON, any writ or process in any AN action or
- 6 proceeding shall be IS conclusive evidence that the writ or process
- 7 was issued by the supreme court in all cases where such IN WHICH
- 8 THE writ or process may be lawfully issued.
 - (2) IF A COURT ORDER HAS BEEN ENTERED IN AN ACTION APPEALED TO THE SUPREME COURT THAT PROHIBITS THE DISCLOSURE OF THE ADDRESS OF A

- 23 OR POLICE OFFICER, OR AN APPOINTED COURT OFFICER SERVE THE PROCESS
- 24 OR PAPERS ON THE PROTECTED PARTY. THE CLERK, SHERIFF, DEPUTY
- 25 SHERIFF, POLICE OFFICER, OR COURT OFFICER SHALL SERVE PROCESS OR
- 26 PAPERS RECEIVED UNDER THIS SUBSECTION AS PROVIDED BY COURT RULE.
