A bill to amend 2003 PA 225, entitled

"An act to designate March 31 of each year as Cesar E. Chavez day in the state of Michigan; to designate July 14 of each year as President Gerald R. Ford day in the state of Michigan; and to designate July 30 of each year as Henry Ford day in the state of Michigan,"

(MCL 435.301 to 435.303) by amending the title and by adding section 4.

- 1 JAPANESE IMMIGRANT PARENTS IN OAKLAND, CALIFORNIA, ON JANUARY 30,
- 2 1919, THE THIRD OF 4 SONS. FRED KOREMATSU WAS 1 OF THE MANY
- 3 AMERICAN CITIZENS OF JAPANESE ANCESTRY LIVING ON THE WEST COAST
- 4 DURING WORLD WAR II. FOLLOWING THE ATTACK ON PEARL HARBOR BY THE
- 5 IMPERIAL JAPANESE NAVY ON DECEMBER 7, 1941, PRESIDENT FRANKLIN
- 6 DELANO ROOSEVELT ISSUED EXECUTIVE ORDER NO. 9066 ON FEBRUARY 19,
- 7 1942. THE ORDER AUTHORIZED THE SECRETARY OF WAR AND HIS MILITARY
- 8 COMMANDERS TO REQUIRE ALL AMERICANS OF JAPANESE ANCESTRY TO BE
- 9 PLACED IN INTERNMENT CAMPS. FRED KOREMATSU IS FAMOUSLY KNOWN FOR
- 10 HIS ARREST, AT THE AGE OF 23, ON MAY 30, 1942, AND CONVICTION ON
- 11 SEPTEMBER 8, 1942 FOR DEFYING THE GOVERNMENT'S ORDER TO REPORT TO
- 12 AN ASSEMBLY CENTER TO BE MOVED TO AN INTERNMENT CAMP. HE APPEALED
- 13 HIS CASE ALL THE WAY TO THE UNITED STATES SUPREME COURT. IN THE
- 14 DECEMBER 1944 LANDMARK DECISION OF KOREMATSU V UNITED STATES, THE
- 15 HIGH COURT RULED AGAINST HIM WITH A 6-TO-3 DECISION THAT DECLARED
- 16 THAT THE INCARCERATION WAS JUSTIFIED BY THE ARMY'S CLAIMS THAT
- 17 AMERICANS OF JAPANESE ANCESTRY WERE RADIO-SIGNALING ENEMY SHIPS
- 18 FROM SHORE AND WERE PRONE TO DISHONESTY. FRED KOREMATSU LATER MOVED
- 19 TO DETROIT, MICHIGAN, WHERE HIS YOUNGER BROTHER RESIDED. THERE HE
- 20 MET HIS WIFE KATHRYN, AND THE 2 WED BEFORE MOVING TO CALIFORNIA, TO
- 21 RAISE THEIR CHILDREN, KAREN AND KEN. FRED KOREMATSU'S CONVICTION
- 22 WAS FORMALLY VACATED ON NOVEMBER 10, 1983 BY UNITED STATES DISTRICT
- 23 JUDGE MARILYN HALL PATEL OF THE UNITED STATES DISTRICT COURT OF
- 24 NORTHERN CALIFORNIA IN SAN FRANCISCO. THIS ACTION, CONSIDERED TO BE
- 25 A PIVOTAL MOMENT IN CIVIL RIGHTS HISTORY, CLEARED FRED KOREMATSU'S
- 26 NAME BUT DID NOT OVERTURN THE 1944 SUPREME COURT DECISION. FRED
- 27 KOREMATSU REMAINED AN ACTIVIST THROUGHOUT HIS LIFE. ON FEBRUARY 9,

- 1 1989, FRED KOREMATSU SPOKE TO 400 STUDENTS, FACULTY, AND FORMER
- 2 INTERNEES AT THE UNIVERSITY OF MICHIGAN LAW SCHOOL. HE SAID,
- 3 "AMERICA FINALLY CAME THROUGH FOR ME, BUT I DON'T WANT THIS TO
- 4 HAPPEN AGAIN". IN 1998, HE RECEIVED THE NATION'S HIGHEST CIVILIAN
- 5 HONOR, THE PRESIDENTIAL MEDAL OF FREEDOM, FROM PRESIDENT CLINTON
- 6 FOR HIS CONTRIBUTIONS. FRED KOREMATSU SERVED ON THE CONSTITUTION
- 7 PROJECT'S BIPARTISAN LIBERTY AND SECURITY COMMITTEE FROM 2001 UNTIL
- 8 HIS DEATH ON MARCH 30, 2005. FRED KOREMATSU WAS RECOGNIZED IN 2010
- 9 WHEN THE STATE OF CALIFORNIA PASSED THE FRED KOREMATSU DAY OF CIVIL
- 10 LIBERTIES AND THE CONSTITUTION BILL, MAKING JANUARY 30 OF EACH YEAR
- 11 THE FIRST DAY IN UNITED STATES HISTORY DESIGNATED TO HONOR AN ASIAN
- 12 AMERICAN. FRED KOREMATSU DAY HAS ALSO BEEN RECOGNIZED IN HAWAII,
- 13 UTAH, GEORGIA, AND VIRGINIA. FRED KOREMATSU IS CONSIDERED BY MANY
- 14 AS A NATIONAL CIVIL RIGHTS HERO WHOSE GROWING LEGACY CONTINUES TO
- 15 INSPIRE PEOPLE OF ALL BACKGROUNDS.
- 16 (2) IN RECOGNITION OF THE CONTRIBUTIONS THAT FRED KOREMATSU
- 17 HAS MADE, THE LEGISLATURE DECLARES THAT JANUARY 30 OF EACH YEAR
- 18 SHALL BE KNOWN AS "FRED KOREMATSU DAY".
