- 24 proposed rule may have on small businesses because of their size.
- 25 (n) An identification of the nature of any report required and
- 26 the estimated cost of its preparation by small businesses required
- 27 to comply with the proposed rule.

- 1 (o) An analysis of the costs of compliance for all small
- 2 businesses affected by the proposed rule, including costs of
- 3 equipment, supplies, labor, and increased administrative costs.
- 4 (p) An identification of the nature and estimated cost of any
- 5 legal consulting and accounting services that small businesses
- 6 would incur in complying with the proposed rule.
- 7 (q) An estimate of the ability of small businesses to absorb
- 8 the costs estimated under subdivisions (n) to (p) without suffering
- 9 economic harm and without adversely affecting competition in the
- 10 marketplace.
- 11 (r) An estimate of the cost, if any, to the agency of
- 12 administering or enforcing a rule that exempts or sets lesser
- 13 standards for compliance by small businesses.
- 14 (s) An identification of the impact on the public interest of
- 15 exempting or setting lesser standards of compliance for small
- 16 businesses.
- 17 (t) A statement describing the manner in which the agency
- 18 reduced the economic impact of the rule on small businesses or a
- 19 statement describing the reasons such a reduction was not feasible.
- (u) A statement describing how the agency has involved small
- 21 businesses in the development of the rule.
- (v) An estimate of the primary and direct benefits of the
- 23 rule.
- 24 (w) An estimate of any cost reductions to businesses,
- 25 individuals, groups of individuals, or governmental units as a
- 26 result of the rule.
- 27 (x) An estimate of any increase in revenues to state or local

- 1 governmental units OF GOVERNMENT as a result of the rule.
- 2 (y) An estimate of any secondary or indirect benefits of the
- 3 rule.
- 4 (z) An identification of the sources the agency relied upon ON
- 5 in compiling the regulatory impact statement, including the
- 6 methodology utilized USED in determining the existence and extent
- 7 of the impact of a proposed rule and a cost-benefit analysis of the
- 8 proposed rule.
- 9 (aa) A detailed recitation of the efforts of the agency to
- 10 comply with the mandate to reduce the disproportionate impact of
- 11 the rule upon ON small businesses as described in section 40(1)(a)
- **12** to (d).
- 13 (bb) Any other information required by the office of
- 14 regulatory reinvention.
- 15 (5) (4) The AN agency shall electronically transmit the
- 16 regulatory impact statement required under subsection  $\frac{(3)}{(4)}$  to
- 17 the office of regulatory reinvention at least 28 days before the
- 18 public hearing required under section 42.—41. Before the public
- 19 hearing can be held, the regulatory impact statement must be
- 20 reviewed and approved by the office of regulatory reinvention. The
- 21 agency shall also electronically transmit a copy of the regulatory
- 22 impact statement to the committee before the public hearing and the

- 7 (b) A repeal of the statutory provision under which the rule
- 8 was authorized.
- 9 (c) A bill staying STAY OF the effective date of the proposed
- 10 rule for up to 1 year.
- 11 (4) The A notice of objection filed under subsection (3) stays
- 12 the ability of the office of regulatory reinvention to file the
- 13 rule with the secretary of state until the earlier of the
- 14 following:
- 15 (a) Fifteen session days after the notice of objection is
- 16 filed under subsection (3).
- 17 (b) The date of the rescission of the issuance of the notice
- 18 of objection, approved by a concurrent majority of the committee
- 19 members. The committee may meet to rescind the issuance of the
- 20 notice of objection under this subdivision. If the committee
- 21 rescinds the issuance of a notice of objection under this
- 22 subdivision, the clerk of the committee shall promptly notify the

- 14 its filing IT IS FILED with the secretary of state unless a later
- 15 effective date is indicated within IN the rule.
- 16 (7) An agency may withdraw a proposed rule under the following
- 17 conditions:
- 18 (a) With permission of the committee chair and alternate
- 19 chair, the agency may withdraw the rule and resubmit it. If
- 20 permission to withdraw is granted, the 15-session-day time period
- 21 described in subsection (1) is tolled until the rule is
- 22 resubmitted. , except that AFTER RESUBMISSION, the committee shall
- 23 have at least HAS THE REMAINDER OF THE 15 SESSION DAYS OR 6 session
- 24 days, after resubmission WHICHEVER IS LONGER, to consider the
- 25 resubmitted rule.
- 26 (b) Without permission of the committee chair and alternate
- 27 chair, the agency may withdraw the rule and resubmit it. If

- 5 (8) Subsections (1) to (5) do not apply to rules adopted under
- 6 sections 33, 44, and 48.
- 7 (9) An agency shall withdraw any rule pending before the
- 8 committee at the final adjournment of a regular session held in an
- 9 even-numbered year and resubmit that THE rule. A new and untolled
- 10 15-session-day time period described in subsection (1) shall begin
- 11 upon BEGINS ON resubmission of the rule to the committee for
- 12 consideration.
- 13 (10) As used in this section only, "session day" means a day
- 14 in which both the house of representatives and the senate convene
- in session and a quorum is recorded.
- 16 Sec. 45b. (1) The office of regulatory reinvention shall post
- 17 the following on its website within 2 business days after
- 18 transmittal pursuant to UNDER section 45:
- 19 (a) The regulatory impact statement required under section
- 20 45(3).45(4).
- 21 (b) Instructions on any existing administrative remedies or
- 22 appeals available to the public.
- 23 (c) Instructions regarding the method of complying with the
- 24 rules, if available.
- 25 (d) Any rules filed with the secretary of state and the
- 26 effective date of those rules.
- 27 (2) The office of regulatory reinvention shall facilitate

- 1 linking the information posted under subsection (1) to the
- 2 department or agency website.
- 3 Enacting section 1. This amendatory act takes effect 90 days
- 4 after the date it is enacted into law.
- 5 Enacting section 2. This amendatory act does not take effect
