

HOUSE BILL No. 4784

July 14, 2015, Introduced by Rep. Faris and referred to the Committee on Appropriations.

A bill to amend 2013 PA 240, entitled
"Michigan state capitol historic site act,"
by amending section 6 (MCL 4.1946).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 6. (1) The commission shall do all of the following:

2 (a) Subject to subsection (2), operate and manage the Michigan
3 state capitol historic site.

4 (b) Maintain and restore the state ~~capitol building~~. **CAPITOL**
5 **BUILDING**.

6 (c) Maintain and improve the grounds of the Michigan state
7 capitol historic site.

8 (d) Appoint an individual to manage the day-to-day operations
9 of the Michigan state capitol historic site. The individual
10 appointed under this subdivision is an at-will employee and ~~shall~~

1 ~~serve~~**SERVES** at the pleasure of the commission.

2 (e) Employ staff to carry out the commission's
3 responsibilities under **THIS** subsection ~~(1)~~—and as otherwise
4 provided by law. All individuals employed by the commission are
5 nontenured, at-will employees. The commission may discipline,
6 transfer, demote, suspend, or summarily discharge an employee.

7 (f) Contract with any person for purposes of procuring goods
8 or services or otherwise carrying out the commission's
9 responsibilities with regard to the Michigan state capitol historic
10 site.

11 (g) Make recommendations to the governor, the senate, and the
12 house of representatives regarding funding for the Michigan state
13 capitol historic site, including, but not limited to, funding from
14 the fund.

15 (h) Carry out other responsibilities as provided by law.

16 **(I) PROVIDE FOR CONSTRUCTION THAT UPDATES THE MICHIGAN**
17 **VETERANS MEMORIAL DESCRIBED IN SECTION 3 (B) (iii) TO RECOGNIZE THE**
18 **CONTRIBUTIONS AND SACRIFICES OF MICHIGAN VETERANS OF ARMED**
19 **CONFLICTS THAT HAVE OCCURRED SINCE THE VIETNAM CONFLICT, INCLUDING,**
20 **BUT NOT LIMITED TO, OPERATION URGENT FURY, OPERATION DESERT SHIELD,**
21 **OPERATION DESERT STORM, THE ARMED CONFLICT IN AFGHANISTAN THAT**
22 **BEGAN IN 2001, AND THE ARMED CONFLICT IN IRAQ THAT BEGAN IN 2003.**

23 **(J) PROVIDE FOR THE CONSTRUCTION OF A MEMORIAL THAT RECOGNIZES**
24 **THE CONTRIBUTIONS AND SACRIFICES OF MICHIGAN WOMEN WHO ARE OR WERE**
25 **VETERANS OF THE WARS AND ARMED CONFLICTS DESCRIBED IN SECTION**
26 **3 (B) (iii) AND SUBDIVISION (I) .**

27 (2) The commission does not have authority and shall not

1 exercise control over the internal decisions of the senate or the
2 house of representatives related to the allocation of space in the
3 ~~state capitol building~~ **STATE CAPITOL BUILDING** or the ~~state capitol~~
4 ~~building~~ **STATE CAPITOL BUILDING** parking lot, including legislative
5 or staff offices. All decisions concerning space in the state
6 ~~capitol building~~ **CAPITOL BUILDING** and the state ~~capitol building~~
7 **CAPITOL BUILDING** parking lot shall be made according to the rules
8 or practices of the senate and the house of representatives.
