

HOUSE BILL No. 4799

Pagan, Chirkun, Liberati, Chang, Plawecki, Phelps, Derek Miller, Love, Hovey-Wright, Durhal, Hoadley, Sarah Roberts, Gay-Dagnogo, Schor, Darany, Brinks, Garrett, Greig, Irwin, Wittenberg, Driskell, Robinson, Singh, Banks, Moss, Byrd, Cochran and Zemke and referred to the Committee on Elections.

A bill to amend 1954 PA 116, entitled
"Michigan election law,"
(MCL 168.1 to 168.992) by adding section 496a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 496A. (1) A PERSON MAY PREREGISTER TO VOTE AT A SECRETARY
2 OF STATE OFFICE IF HE OR SHE MEETS ALL OF THE FOLLOWING
3 REQUIREMENTS:

4 (A) IS AT LEAST 16 YEARS OF AGE BUT LESS THAN 17-1/2 YEARS OF
5 AGE.

6 (B) HAS BEEN ISSUED EITHER A GRADUATED LICENSING STATUS TO
7 OPERATE A MOTOR VEHICLE UNDER SECTION 310E OF THE MICHIGAN VEHICLE
8 CODE, 1949 PA 300, MCL 257.310E, OR AN OFFICIAL STATE PERSONAL
9 IDENTIFICATION CARD UNDER 1972 PA 222, MCL 28.291 TO 28.300.

10 (C) IS A CITIZEN OF THE UNITED STATES.

11 (2) THE SECRETARY OF STATE IS AUTHORIZED TO CREATE A

1 PREREGISTRATION TO VOTE APPLICATION. A PERSON SHALL PREREGISTER TO
2 VOTE ON THE APPLICATION PRESCRIBED BY THE SECRETARY OF STATE.

3 (3) A PERSON WHO PREREGISTERS TO VOTE UNDER THIS SECTION SHALL
4 BECOME A REGISTERED ELECTOR AT 17-1/2 YEARS OF AGE AND BECOME
5 ELIGIBLE TO VOTE AT THE FIRST ELECTION AFTER HE OR SHE BECOMES 18
6 YEARS OF AGE.

7 (4) IMMEDIATELY UPON RECEIPT OF A PREREGISTRATION TO VOTE
8 APPLICATION, THE SECRETARY OF STATE SHALL TRANSMIT THE
9 PREREGISTRATION TO VOTE APPLICATION TO THE APPROPRIATE CITY OR
10 TOWNSHIP CLERK AND SHALL TRANSMIT THE ELECTRONIC DATA FOR THE
11 PREREGISTRATION TO THE QUALIFIED VOTER FILE. THE PREREGISTRATION TO
12 VOTE APPLICATION SHALL BE HELD IN A SEPARATE FILE AND SHALL NOT BE
13 MOVED TO THE MASTER FILE UNTIL THE PERSON WHO FILED THE
14 PREREGISTRATION TO VOTE APPLICATION BECOMES 17-1/2 YEARS OF AGE.

15 (5) THE QUALIFIED VOTER FILE SHALL NOT INCLUDE THE NAME OF A
16 PERSON WHO PREREGISTERS TO VOTE ON A PRECINCT VOTER LIST BEFORE THE
17 PERSON BECOMES 18 YEARS OF AGE.

18 (6) IF A PERSON WHO PREREGISTERS TO VOTE CHANGES THE ADDRESS
19 THAT APPEARS ON HIS OR HER DRIVER LICENSE OR PERSONAL
20 IDENTIFICATION CARD, THE PREREGISTRATION TO VOTE ADDRESS FOR THAT
21 PERSON SHALL ALSO BE CHANGED.

22 (7) WHEN A PERSON WHO PREREGISTERS TO VOTE BECOMES 17-1/2
23 YEARS OF AGE, THE SECRETARY OF STATE SHALL SEND A NOTICE THROUGH
24 THE QUALIFIED VOTER FILE TO THE APPROPRIATE CITY OR TOWNSHIP CLERK
25 DIRECTING THE CLERK TO SEND A VOTER IDENTIFICATION CARD TO THE
26 PERSON WHO PREREGISTERED TO VOTE.

27 (8) THE CITY OR TOWNSHIP CLERK WHO RECEIVES A NOTICE FROM THE

1 SECRETARY OF STATE PURSUANT TO SUBSECTION (7) SHALL SEND A VOTER
2 IDENTIFICATION CARD TO THE PERSON WHO PREREGISTERED TO VOTE AND
3 SHALL ADD THAT PERSON TO THE MASTER FILE.
