A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 811mm.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811MM. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
- 2 SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE
- 3 RECOGNIZING SOJOURNER TRUTH. THE SECRETARY OF STATE IN CONJUNCTION
- 4 WITH THE SOJOURNER TRUTH MUSEUM SHALL DESIGN THE FUND-RAISING
- 5 PLATES AUTHORIZED IN THIS SECTION.
- 6 (2) THE SOJOURNER TRUTH MUSEUM FUND IS CREATED WITHIN THE
 - STATE TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR OTHER
- 8 ASSETS FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE
- 9 TREASURER SHALL DIRECT THE INVESTMENT OF THE FUND. THE STATE
- 10 TREASURER SHALL CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND
- 11 INVESTMENTS. MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR

- 1 SHALL REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
- 2 THE STATE TREASURER SHALL BE THE ADMINISTRATOR OF THE FUND FOR
- 3 AUDITING PURPOSES.
- 4 (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY
- 5 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING SOJOURNER TRUTH TO
- 6 THE STATE TREASURER, WHO SHALL CREDIT THE DONATION MONEY TO THE
- 7 FUND ESTABLISHED UNDER SUBSECTION (2).
- 8 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE FUND
- 9 ESTABLISHED UNDER SUBSECTION (2) ON A QUARTERLY BASIS TO THE
- 10 SOJOURNER TRUTH MUSEUM.
- 11 Enacting section 1. This amendatory act takes effect 90 days
- 12 after the date it is enacted into law.
