- 4 AND THE PROCESS TO FOLLOW IF THE FOSTER CHILD HAS CONCERNS
- 5 REGARDING A VIOLATION OF THE CHILDREN'S ASSURANCE OF QUALITY FOSTER
- 6 CARE POLICY. THIS INFORMATION SHALL INCLUDE INFORMATION REGARDING
- 7 THE FOSTER CHILD'S CASEWORKER, LEGAL GUARDIAN AD LITEM, THE OFFICE
- 8 OF THE CHILDREN'S OMBUDSMAN, HOW TO FILE A COMPLAINT, AND WHOM THE
