## **HOUSE BILL No. 5010**

A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1241.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1241. (1) THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE
- 2 SCHOOL DISTRICT, BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY, OR
- 3 GOVERNING BODY OF A STATE APPROVED NONPUBLIC SCHOOL MAY ENTER INTO
- 4 AN AGREEMENT WITH A QUALIFIED VOLUNTEER TO PATROL SCHOOL PREMISES
- 5 FOR THE SOLE PURPOSE OF PREVENTING OR RESPONDING TO A MASS CASUALTY
- 6 EVENT CONNECTED WITH ILLEGAL ACTIVITY. TO IDENTIFY A QUALIFIED
- 7 VOLUNTEER, THE BOARD, BOARD OF DIRECTORS, OR GOVERNING BODY MAY
- 8 REQUEST A COPY OF THE LIST MAINTAINED BY THE MICHIGAN STATE POLICE
  - UNDER SECTION 17 OF 1935 PA 59, MCL 28.17. IF THE QUALIFIED

- 1 VOLUNTEER IS CURRENTLY EMPLOYED AS A LAW ENFORCEMENT OFFICER, THE

- 18 ARISING FROM THE QUALIFIED VOLUNTEER'S PERFORMANCE OF SERVICES
- 19 UNDER THIS SECTION UNLESS THE INJURY, DEATH, OR LOSS RESULTED FROM
- 20 THE QUALIFIED VOLUNTEER'S RECKLESS OR WANTON CONDUCT.
- 21 (3) AS USED IN THIS SECTION, "QUALIFIED VOLUNTEER" MEANS AN
- 22 INDIVIDUAL WHO IS ON THE LIST MAINTAINED BY THE MICHIGAN STATE
- 23 POLICE UNDER SECTION 17 OF 1935 PA 59, MCL 28.17.
- 24 Enacting section 1. This amendatory act takes effect 90 days
- 25 after the date it is enacted into law.
- 26 Enacting section 2. This amendatory act does not take effect
- 27 unless all of the following bills of the 98th Legislature are
