

HOUSE BILL No. 5106

December 2, 2015, Introduced by Rep. Barrett and referred to the Committee on Military and Veterans Affairs.

A bill to amend 1967 PA 150, entitled
"Michigan military act,"
by amending section 151 (MCL 32.551), as amended by 2013 PA 99.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 151. (1) The governor is the commander-in-chief of the
2 organized militia. He **OR SHE** may order to active state service any
3 members of the organized militia in case of riot, tumult, breach of
4 the peace, **OR** resistance of process, or for service in aid of civil
5 authority, whether state or federal, or in time of actual or
6 imminent public danger, disaster, crisis, catastrophe, or other
7 public emergency within this state or to respond to acts or threats
8 of terrorism or to safeguard military or other vital resources of
9 this state or of the United States. If the governor and his **OR HER**

1 legal successor are absent ~~—OR~~ disabled ~~—or~~ cannot be
2 communicated with, the adjutant general, if he **OR SHE** believes the
3 danger great and imminent, may order out, in the name of the
4 governor, such troops of the organized militia as he **OR SHE**
5 believes necessary to meet the emergency.

6 (2) THE GOVERNOR OR THE ADJUTANT GENERAL MAY ORDER TO ACTIVE
7 STATE SERVICE ANY MEMBER OF THE MICHIGAN NATIONAL GUARD FOR DUTIES
8 IN SUPPORT OF THE FULL-TIME OPERATION OF THE STATE MILITARY
9 ESTABLISHMENT.

10 (3) THE DEPARTMENT OF MILITARY AND VETERANS AFFAIRS SHALL
11 REPORT TO THE LEGISLATURE IF ANY MEMBERS OF THE MICHIGAN NATIONAL
12 GUARD WHO HAVE BEEN ORDERED TO ACTIVE STATE SERVICE UNDER
13 SUBSECTION (2) HAVE SERVED ON ACTIVE STATE SERVICE FOR MORE THAN 15
14 DAYS DURING THEIR SERVICE WITH THE MICHIGAN NATIONAL GUARD. THE
15 DEPARTMENT OF MILITARY AND VETERANS AFFAIRS SHALL ANNUALLY SUBMIT A
16 REPORT TO THE LEGISLATURE THAT INCLUDES THE NAME OF EACH MEMBER OF
17 THE MICHIGAN NATIONAL GUARD WHO HAS SERVED MORE THAN 15 DAYS ON
18 ACTIVE STATE SERVICE DURING HIS OR HER SERVICE WITH THE MICHIGAN
19 NATIONAL GUARD AND THE NUMBER OF DAYS THAT SERVICE MEMBER HAS
20 SERVED ON ACTIVE STATE SERVICE.

21 Enacting section 1. This amendatory act takes effect 90 days
22 after the date it is enacted into law.
