

# HOUSE BILL No. 5220

January 14, 2016, Introduced by Reps. Phelps and Neeley and referred to the Committee on Appropriations.

A bill to make, supplement, and adjust appropriations for various state departments and agencies for the fiscal year ending September 30, 2016; and to provide for the expenditure of the appropriations.

6 **GENERAL SECTIONS**

7 Sec. 201. In accordance with the provisions of section 30 of  
 8 article IX of the state constitution of 1963, total state spending  
 9 from state resources in this appropriation act for the fiscal year  
 10 ending September 30, 2016 is \$100.00 and state appropriations paid  
 11 to local units of government are \$0.00.

12 Sec. 202. The appropriations made and expenditures authorized  
 13 under this act and the departments, commissions, boards, offices,  
 14 and programs for which appropriations are made under this act are  
 15 subject to the management and budget act, 1984 PA 431, MCL 18.1101  
 16 to 18.1594.

17 **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

18 Sec. 301. From the funds appropriated in part 1 for Flint  
 19 emergency assistance, the department of health and human services  
 20 shall use the funds to assist the residents of the city of Flint  
 21 due to the state of emergency declared by the governor for Genesee  
 22 County on January 5, 2016.
