A bill to make, supplement, and adjust appropriations for  
certain capital outlay projects for the fiscal year ending  
September 30, 2016; to provide for expenditure of the  
appropriations; and to prescribe certain conditions for the  
appropriations.

22 **GENERAL SECTIONS**

23 Sec. 201. In accordance with the provisions of section 30 of  
 24 article IX of the state constitution of 1963, total state spending  
 25 from state resources in this appropriation act for the fiscal year  
 26 ending September 30, 2016 is \$27,957,200.00. State appropriations



1 paid to local units of government are \$21,782,200.00 as follows:

5       Sec. 202. The appropriations authorized under this act are  
 6 subject to the management and budget act, 1984 PA 431, MCL 18.1101  
 7 to 18.1594.

#### 8 MICHIGAN NATURAL RESOURCES TRUST FUND

9       Sec. 301. (1) The department of natural resources shall enter  
 10 into agreements with local units of government for the purpose of  
 11 administering the grants identified in part 1. Among other  
 12 provisions, the agreements shall require that grant recipients  
 13 agree to dedicate to public outdoor recreation uses in perpetuity  
 14 the land acquired or developed; to replace lands converted or lost  
 15 to other than public outdoor recreation use; and, for parcels  
 16 acquired that are over 5 acres in size, to provide the state with a  
 17 nonparticipating 1/6 minimum royalty interest in any acquired  
 18 minerals that are retained by the grant recipient.

19       (2) The agreements under subsection (1) shall also provide  
 20 that the full payments of grants shall be made only after proof of  
 21 acquisition, or proof of completion of the development project, is  
 22 submitted by the grant recipient and all costs are verified by the  
 23 department of natural resources. This requirement may be waived by  
 24 the department of natural resources.

25       Sec. 302. The appropriations in part 1 for capital outlay  
 26 shall be carried forward at the end of the fiscal year consistent

1 with the provisions of section 248 of the management and budget  
2 act, 1984 PA 431, MCL 18.1248.

3       Sec. 303. (1) The state share of the following capital outlay  
4 appropriations authorized in 2013 PA 9 for Michigan natural  
5 resources trust fund projects that have since been withdrawn by the  
6 grantees are hereby reduced up to the amounts indicated and the  
7 funds lapsed for the purpose of redirecting resources to Michigan  
8 natural resources trust fund projects appropriated in part 1:
