February 24, 2016, Introduced by Rep. Phelps and referred to the Committee on Appropriations.

A bill to make, supplement, and adjust appropriations for various state departments and agencies for the fiscal year ending September 30, 2016; and to provide for the expenditure of the appropriations.

8 **GENERAL SECTIONS**

9 Sec. 201. In accordance with the provisions of section 30 of
 10 article IX of the state constitution of 1963, total state spending
 11 from state resources in this appropriation act for the fiscal year
 12 ending September 30, 2016 is \$100.00 and state appropriations paid
 13 to local units of government are \$0.00.

14 Sec. 202. The appropriations made and expenditures authorized
 15 under this act and the departments, commissions, boards, offices,
 16 and programs for which appropriations are made under this act are
 17 subject to the management and budget act, 1984 PA 431, MCL 18.1101
 18 to 18.1594.

19 **DEPARTMENT OF STATE POLICE**

20 Sec. 301. From the funds appropriated in part 1 for Flint
 21 emergency response assistance, the department of state police shall
 22 use the funds to assist the residents of the city of Flint due to
 23 the state of emergency declared by the governor for Genesee County
 24 on January 5, 2016.
