A bill to amend 1976 PA 399, entitled "Safe drinking water act," by amending section 3 (MCL 325.1003).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 3. (1) Subject to SUBSECTION (2) AND THE limitations

  contained in this act, the department shall have power and control

  over public water supplies and suppliers of water. The director may

  enter upon the waterworks system of a supplier of water at

  reasonable times for the purpose of inspecting the system and

  carrying out this act and rules promulgated under this act.
  - (2) THE WATER RESOURCES COMMISSION CREATED IN SECTION 3102 OF THE NATURAL RESOURCES AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, MCL 324.3102, SHALL DO ALL OF THE FOLLOWING:

- 10 (D) IN RESPONSE TO A COMPLAINT REGARDING DRINKING WATER, DO

- 12 (i) REQUIRE THE DIRECTOR OR THE DEPARTMENT TO TAKE
- 13 INVESTIGATORY OR ENFORCEMENT ACTION.
- 14 (ii) REQUEST THE ATTORNEY GENERAL TO COMMENCE AN ACTION IN
- 15 COURT TO ENFORCE THIS ACT.
- 16 Enacting section 1. This amendatory act takes effect 90 days
- 17 after the date it is enacted into law.
