## **HOUSE BILL No. 5435**

March 8, 2016, Introduced by Reps. Lauwers, Victory and VerHeulen and referred to the Committee on Workforce and Talent Development.

A bill to amend 2002 PA 733, entitled "State plumbing act," by amending section 15 (MCL 338.3525).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 15. (1) A person shall not engage in or work at the
- 2 business of a plumbing contractor, master plumber, journey plumber,
- 3 or apprentice plumber unless licensed or registered by the
- 4 department. Except as provided in subsections (2), (3), (4), and
- 5 (5), plumbing shall be performed by a licensed master or journey
- 6 plumber. A licensed master plumber shall be in charge and
- 7 responsible for proper installation and conformance with the code.
- 8 Plumbing shall not be performed unless the plumbing contractor who
- is responsible has secured a permit from the state or a

- 1 governmental subdivision authorized to issue permits.
- 2 (2) A license is not required for ANY OF the following work:
- 3 (a) Minor repair work.
- 4 (b) The installation of a building sewer or water service pipe
- 5 provided that IF a permit is secured from the responsible enforcing
- 6 agency, and REQUIRED inspections are performed, . The installations
- 7 shall comply AND THE INSTALLATION COMPLIES with the applicable
- 8 code.
- 9 (c) The installation of domestic water treatment and filtering
- 10 equipment that requires modification to an existing cold water
- 11 distribution supply and associated waste piping in buildings if a
- 12 permit is secured, required inspections ARE performed, and the
- 13 installation complies with the applicable code. If the enforcing
- 14 agency determines THAT a violation OF THE APPLICABLE CODE exists,
- 15 it shall be corrected by the responsible installer SHALL CORRECT
- 16 THE VIOLATION.
- 17 (D) THE REPLACEMENT OF A DOMESTIC WATER HEATER IN A 1-FAMILY
- 18 OR 2-FAMILY DWELLING THAT REQUIRES MODIFICATION TO AN EXISTING HOT
- 19 AND COLD WATER DISTRIBUTION SUPPLY BY A MECHANICAL CONTRACTOR
- 20 LICENSED IN A CLASSIFICATION LISTED IN SECTION 6(3)(A), (B), (D),
- 21 (E), (F), (G), OR (H) OF THE FORBES MECHANICAL CONTRACTORS ACT,
- 22 1984 PA 192, MCL 338.976, IF A PERMIT IS SECURED, REQUIRED
- 23 INSPECTIONS ARE PERFORMED, AND THE INSTALLATION COMPLIES WITH THE
- 24 APPLICABLE CODE.
- 25 (3) A homeowner may install his or her own plumbing, building
- 26 sewer, or private sewer in his or her single-family dwelling if a
- 27 permit is secured.

- 1 (4) The A LICENSE IS NOT REQUIRED FOR THE installation of
  2 medical gas piping providing IF the installation shall be IS
  3 performed under the supervision of a licensed plumbing contractor.
- 4 (5) This act does not prevent a person from performing any
  5 activities within the scope of licensure or registration under any
  6 other licensure or registration act or applicable codes for that
  7 licensed or registered professional adopted pursuant to law.
- Enacting section 1. This amendatory act takes effect 90 daysafter the date it is enacted into law.
