## **HOUSE BILL No. 5460**

March 15, 2016, Introduced by Reps. Phelps, Neeley, Chang, Garrett, Brunner, Hoadley, Guerra, Schor, Faris, Durhal, Dianda, Geiss, LaVoy, Hovey-Wright, Irwin, Brinks and Moss and referred to the Committee on Local Government.

A bill to amend 1976 PA 390, entitled

"Emergency management act,"

by amending section 7a (MCL 30.407a), as amended by 2002 PA 132.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 7a. (1) The department shall establish an emergency management division for the purpose of coordinating within this state the emergency management activities of county, municipal, state, and federal governments. The department shall provide the division with professional and support employees as necessary for the performance of its functions.

(2) The division shall prepare and maintain a Michigan emergency management plan that is a comprehensive plan that encompasses mitigation, preparedness, response, and recovery for

- 22 (C) THE PLAN TO ADDRESS OTHER PUBLIC HEALTH ISSUES ASSOCIATED

- 25 (D) A PUBLIC EDUCATION PLAN THAT, UPON IDENTIFICATION OF THE
- 26 HARMFUL ISSUES WITH A MUNICIPAL WATER SUPPLY, PROVIDES THE
- 27 IMMEDIATE EDUCATION OF RESIDENTS REGARDING THE RISK OF HARM AND HOW
