A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 811ww.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811WW. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
- 2 SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE
- 3 RECOGNIZING AUTISM AWARENESS. THE SECRETARY OF STATE SHALL DESIGN
- 4 THE FUND-RAISING PLATES AUTHORIZED IN THIS SECTION.
- 5 (2) THE AUTISM AWARENESS FUND IS CREATED WITHIN THE STATE
- 6 TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS
 - FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE TREASURER
 - SHALL DIRECT THE INVESTMENT OF THE FUND. THE STATE TREASURER SHALL
- 9 CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS.
- 10 MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL REMAIN IN
- 11 THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND. THE STATE

- 1 TREASURER SHALL BE THE ADMINISTRATOR OF THE FUND FOR AUDITING
- 2 PURPOSES.
- 3 (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY
- 4 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING AUTISM AWARENESS
- 5 TO THE STATE TREASURER, WHO SHALL CREDIT THE DONATION MONEY TO THE
- 6 FUND ESTABLISHED UNDER SUBSECTION (2).
- 7 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE FUND

- 10 Enacting section 1. This amendatory act takes effect 90 days
