HOUSE BILL No. 5595

April 26, 2016, Introduced by Reps. Brunner, Love, Guerra, Pagan, Plawecki, Smiley, Glenn, Geiss, Hughes and Lane and referred to the Committee on Judiciary.

A bill to amend 1994 PA 295, entitled "Sex offenders registration act,"

by amending section 33 (MCL 28.733), as added by 2005 PA 127, and by adding section 34a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 33. As used in this article:
 - (A) "CHILD CARE ORGANIZATION" MEANS THAT TERM AS DEFINED IN SECTION 1 OF 1973 PA 116, MCL 722.111, AND LICENSED OR REGULATED UNDER 1973 PA 116, MCL 722.111 TO 722.128.
 - (B) (a) "Listed offense" means that term as defined in section 2 of the sex offenders registration act, 1994 PA 295, MCL 28.722.
 - (C) (b)—"Loiter" means to remain for a period of time and

- 22 SEC. 34A. A SCHOOL MAY MARK ITS SCHOOL PROPERTY WITH SIGNAGE
- 23 BEARING THE INTERNATIONAL SYMBOL FOR A CHILD AND LOCATION OF SCHOOL
- 24 PROPERTY. THE SIGNAGE DESCRIBED IN THIS SECTION SHALL BE OF A SIZE
- 25 AND STANDARD COLOR AS DETERMINED BY THE DEPARTMENT.
- 26 Enacting section 1. This amendatory act takes effect 90 days
- 27 after the date it is enacted into law.
