HOUSE BILL No. 5617

May 3, 2016, Introduced by Rep. Faris and referred to the Committee on Criminal Justice.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending section 316 (MCL 750.316), as amended by 2014 PA 158.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 316. (1) Except as provided in sections 25 and 25a of
- 2 chapter IX of the code of criminal procedure, 1927 PA 175, MCL
- 3 769.25 and 769.25a, a person who commits any of the following is
- 4 quilty of first degree murder and shall be punished by imprisonment
- 5 for life without eligibility for parole:
 - (a) Murder perpetrated by means of poison, lying in wait, or any other willful, deliberate, and premeditated killing.
 - (b) Murder committed in the perpetration of, or attempt to perpetrate, arson, criminal sexual conduct in the first, second, or

- 1 third degree, child abuse in the first degree OR SECOND DEGREE, a
- 2 major controlled substance offense, robbery, carjacking, breaking
- 3 and entering of a dwelling, home invasion in the first or second
- 4 degree, larceny of any kind, extortion, kidnapping, vulnerable
- 5 adult abuse in the first or second degree under section 145n,
- 6 torture under section 85, aggravated stalking under section 411i,
- 7 or unlawful imprisonment under section 349b.
- 8 (c) A murder of a peace officer or a corrections officer
- 9 committed while the peace officer or corrections officer is
- 10 lawfully engaged in the performance of any of his or her duties as
- 11 a peace officer or corrections officer, knowing that the peace
- 12 officer or corrections officer is a peace officer or corrections
- 13 officer engaged in the performance of his or her duty as a peace
- 14 officer or corrections officer.
- 15 (2) As used in this section:
- 16 (a) "Arson" means a felony violation of chapter X.
- 17 (b) "Corrections officer" means any of the following:
- (i) A prison or jail guard or other prison or jail personnel.

- 20 incarceration unit, or other minimum security correctional
- 21 facility.
- 22 (iii) A parole or probation officer.
- (c) "Major controlled substance offense" means any of the

- 27 (ii) A violation of section 7403(2)(a)(i) to (iii) of the

- 2 (iii) A conspiracy to commit an offense listed in subparagraph

- 4 (d) "Peace officer" means any of the following:
- 5 (i) A police or conservation officer of this state or a
- 6 political subdivision of this state.
- 7 (ii) A police or conservation officer of the United States.
- 8 (iii) A police or conservation officer of another state or a
- 9 political subdivision of another state.
