## **HOUSE BILL No. 5639**

May 11, 2016, Introduced by Reps. Hughes, Barrett, Hooker, Whiteford, Rutledge, LaGrand, Crawford, Lucido, Outman, Chatfield, Talabi, Glenn, Lyons, Hovey-Wright, Jenkins, Sheppard, Glardon and Howell and referred to the Committee on Oversight and Ethics.

A bill to amend 1885 PA 152, entitled

"An act to authorize the establishment of facilities for former members of the armed forces of the United States in the state of Michigan; to create funds; and to provide for the promulgation of rules,"

(MCL 36.1 to 36.12) by adding section 9.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 9. NO LATER THAN JANUARY 1, APRIL 1, JULY 1, AND OCTOBER
- 2 1 OF EACH YEAR, THE MICHIGAN VETERANS AFFAIRS AGENCY, ITS SUCCESSOR
- 3 AGENCY, OR THE DEPARTMENT OF MILITARY AND VETERANS AFFAIRS SHALL
- 4 REPORT IN WRITING ALL OF THE FOLLOWING INFORMATION CONCERNING THE
- 5 STATE VETERANS' FACILITY TO THE SENATE AND HOUSE COMMITTEES ON
  - VETERANS AFFAIRS AND THE SENATE AND HOUSE APPROPRIATIONS
- SUBCOMMITTEES FOR THE DEPARTMENT OF MILITARY AND VETERANS AFFAIRS:
- 8 (A) STAFFING LEVELS AND THE EXTENT TO WHICH STAFFING LEVELS DO
- 9 OR DO NOT MEET INDUSTRY STANDARDS.

- 1 (B) NUMBER OF PATIENT COMPLAINTS, AVERAGE TIME TO REVIEW A
- 2 COMPLAINT AND RESPOND, AND RESPONSE TO EACH COMPLAINT.
- 3 (C) TIMELINESS OF DISTRIBUTION OF PHARMACEUTICAL DRUGS.
- 4 (D) SECURITY PROVIDED FOR PHARMACEUTICAL DRUGS IN THE
- 5 FACILITY, INCLUDING THE TITLE OF THE INDIVIDUALS PROVIDING THE

- 7 (E) HOW PATIENT MONEY IS ACCOUNTED FOR, INCLUDING THE NAME AND

- 11 Enacting section 1. This amendatory act takes effect 90 days
- 12 after the date it is enacted into law.
