A bill to amend 1972 PA 284, entitled "Business corporation act,"

by amending section 911 (MCL 450.1911), as amended by 2012 PA 569.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

administrator no later than May 15 of each year. The report shall
