HOUSE BILL No. 5876

September 14, 2016, Introduced by Reps. Barrett and Hughes.

A bill to amend 1885 PA 152, entitled

"An act to authorize the establishment of facilities for former members of the armed forces of the United States in the state of Michigan; to create funds; and to provide for the promulgation of rules,"

by amending sections 2a and 8 (MCL 36.2a and 36.8), section 2a as amended by 2016 PA 213 and section 8 as amended by 2011 PA 283, and by adding section 1a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1A. (1) A MICHIGAN VETERANS' FACILITY SHALL COMPLY WITH
- 2 ALL OF THE RULES AND REGULATIONS FOR A NURSING HOME AS PROVIDED IN

- 1 (2) THE DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS SHALL

- 23 Sec. 2a. (1) The SUBJECT TO SECTION 1A, THE general OPERATION,

- 15 Sec. 8. The board of managers shall meet not less than once
- 16 every 3 months. The board of managers—shall prepare, review, and
- 17 revise a system of government for the homes, which shall include
- 18 all rules, regulations, and laws necessary for effective management
- 19 and preserving the health of the disabled veterans admitted to the
- 20 home. HOWEVER, THIS SECTION IS SUBJECT TO SECTION 1A.
