THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1706. (1) THE OFFICE OF THE IEP OMBUDSMAN IS CREATED IN
- 2 THE DEPARTMENT WITHIN THE OFFICE OF SPECIAL EDUCATION.
- 3 (2) THE STATE BOARD SHALL DESIGNATE AN INDIVIDUAL AS THE IEP
- 4 OMBUDSMAN, WHO SHALL SERVE AS THE PRINCIPAL EXECUTIVE OFFICER OF
- 5 THE OFFICE OF THE IEP OMBUDSMAN. THE DEPARTMENT MAY APPOINT
- 6 EMPLOYEES AND OTHER AGENTS OF THE OFFICE OF THE IEP OMBUDSMAN AND
- 7 PRESCRIBE THEIR DUTIES, CONSISTENT WITH THIS SECTION.
- 8 (3) THE IEP OMBUDSMAN SHALL ENSURE THAT THE GOALS OF

- 18 (4) THE DEPARTMENT SHALL MAKE AVAILABLE TO ALL SCHOOL
- 19 DISTRICTS, INTERMEDIATE SCHOOL DISTRICTS, PUBLIC SCHOOL ACADEMIES,
- 20 AND APPROPRIATE SPECIAL EDUCATION PERSONNEL INFORMATION REGARDING
- 21 THE OFFICE OF THE IEP OMBUDSMAN, INCLUDING, BUT NOT LIMITED TO,
- 22 CONTACT INFORMATION AND A DESCRIPTION OF SERVICES OFFERED. SCHOOL
- 23 DISTRICTS, INTERMEDIATE SCHOOL DISTRICTS, PUBLIC SCHOOL ACADEMIES,
- 24 AND SPECIAL EDUCATION PERSONNEL ARE ENCOURAGED TO DISSEMINATE THAT
- 25 INFORMATION TO PUPILS AND PARENTS OR GUARDIANS, AS CONSIDERED
- 26 APPROPRIATE.
- 27 (5) AS USED IN THIS SECTION, "INDIVIDUALIZED EDUCATION
