## **HOUSE BILL No. 6026**

November 9, 2016, Introduced by Rep. Chang and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding sections 1278d and 1528.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1278D. (1) IN ADDITION TO THE REQUIREMENTS OF SECTIONS
- 2 1278A AND 1278B, BEGINNING IN 2017, THE BOARD OF A SCHOOL DISTRICT
- 3 OR BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY SHALL NOT AWARD A
- 4 HIGH SCHOOL DIPLOMA TO A PUPIL UNLESS THE PUPIL HAS COMPLETED
- 5 DURING HIGH SCHOOL AT LEAST 2 HOURS OF INSTRUCTION CONCERNING
- 6 SEXUAL ASSAULT AND SEXUAL HARASSMENT. THE INSTRUCTION SHALL COVER
- 7 AT LEAST IDENTIFICATION AND RECOGNITION OF SEXUAL ASSAULT AND
- 8 SEXUAL HARASSMENT, ACTIONS TO BE TAKEN AND RESOURCES AVAILABLE IF
- 9 THE PUPIL EXPERIENCES SEXUAL ASSAULT OR SEXUAL HARASSMENT, AND
- 10 ACTIONS TO BE TAKEN AND RESOURCES AVAILABLE IF THE PUPIL KNOWS AN

- 15 SEC. 1528. BEGINNING IN 2016-2017, THE BOARD OF A SCHOOL
- 16 DISTRICT OR INTERMEDIATE SCHOOL DISTRICT OR BOARD OF DIRECTORS OF A
- 17 PUBLIC SCHOOL ACADEMY, TOGETHER WITH A LOCAL ORGANIZATION THAT
- 18 RECEIVES FUNDING FROM THE MICHIGAN DOMESTIC AND SEXUAL VIOLENCE
- 19 PREVENTION AND TREATMENT BOARD AND THAT SERVES THE GEOGRAPHIC AREA
- 20 OF THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC
- 21 SCHOOL ACADEMY, IS ENCOURAGED TO PROVIDE EACH OF ITS TEACHERS WITH
- 22 TRAINING AT LEAST EVERY 5 YEARS IN RESPONDING TO PUPILS WHO HAVE
- 23 EXPERIENCED SEXUAL ASSAULT OR SEXUAL HARASSMENT. THIS TRAINING MAY
- 24 BE PROVIDED AS PART OF THE PROFESSIONAL DEVELOPMENT PROVIDED UNDER
- 25 SECTION 1527.
- 26 Enacting section 1. This amendatory act takes effect 90 days
- 27 after the date it is enacted into law.
